New Faculty Spotlight

Dr. Claude Bonazzo



Joining this department has been a dream of mine! My passion for sociology started in this department more than 15 years ago. I got my bachelor's in applied sociology (2001) and my master's in sociology (2004) in this department. I had such a wonderful experience with the professors and students that I really wanted to return one day to teach and give back to a community that really supported me. Prior to coming to Texas State, I taught classes at the Austin Community College and as a teaching assistant at the University of Texas at Austin.

My teaching and research interests are on race/ethnicity, education, health, and disability. My

dissertation was a mixed methods study that sought to identify policy-relevant mechanisms that aim to improve the educational prospects of Latinxs in the United States, a group with traditionally lower levels of educational attainment compared with other race/ethnic groups. I focused on children in elementary school, which is increasingly viewed as a critical window for intervention in the intergenerational transmission of inequality. Within this educational stage, I focused on parent-teacher relations, which has generated much theoretical and policy attention. I explored the potential support generated for the educational involvement of Latinxs parents based on being ethnically matched with their children's teachers as their children move through elementary school.

I am incredibly grateful to join Texas State's Department of Sociology to serve the faculty and especially the students.

Faculty Spotlight: Big Awards



Dr. Gloria Martínez-Ramos: 2019 Recipient of the Texas State University Mariel Muir Mentoring Award

Dr. Gloria Martínez-Ramos is the faculty recipient of 2019-20 Mariel Muir Mentoring Award for her dedication and strong commitment to mentoring students, faculty, and staff to ensure their success. Texas State University named this award in honor of Dr. Muir, the former dean of the College of Science and Engineering to recognized her strong commitment to mentoring. Dr. Martínez-Ramos' mentoring goes beyond one-on-one mentoring with students and faculty. Her one-on-one and group mentoring is a form of inclusive mentoring; she mentors in in multiple ways with many different groups. Our department, college, university, and local community are fortunate to have such an exceptional role model.

Dr. Rachel Romero: 2019 Recipient of the Texas State University Presidential Award and College of Liberal Arts Award in Teaching

Dr. Rachel Romero, Senior Lecturer and Associate Graduate Director of Graduate Programs, has received several teaching honors and awards, including the Alpha Chi Favorite Professor Awards, the John R. Hood Honors Professor of the Year Award, and a College of Liberal Arts Achievement Award for Excellence in Teaching. She has also received a Graduating Student Recognition in every semester that she has taught. Since joining our department, she has been actively engaged with mentoring and supporting undergraduate and graduate students by writing papers with students, supervising independent studies, and serving on honors theses, and graduate theses. Her mentees, many of whom are award recipients, go on to impressive jobs (e.g. applied researchers, teachers, and positions in non-

profit organizations) and graduate programs. As part of Dr. Romero's innovative teaching, she encourages students to engage in self-reflection and goes beyond simply asking them to apply the course material. She pushes students to interrogate how inequalities influence their everyday lives. Dr. Romero offers and values a highly participatory classroom that breaks down the hierarchy between faculty instructors and students. She sees her classrooms as "communities of learners," and imparts this democratic message in how she teaches, her welcoming of diverse ideas, and her open and authentic presentation of self. Dr. Romero teaches an innovative honors course that integrates her research specializations on "Art-Based Research Methods." In fall 2020, Dr. Romero will become a tenure-track assistant professor for our department.



Professor Lillian Dee's Retirement

In the fall of 2019, Lillian Dees retired from the Department of Sociology after serving as a faculty member since 1990. She began teaching as an adjunct while employed full-time by the university and she eventually became a full-time faculty member as a senior lecturer. However, Lillian's time at Texas State spans more than five decades - 57 years in all. Lillian stepped foot onto the campus, on what was then called Southwest Texas State College, as an administrative secretary in the Department of Journalism and News Service in September of 1962. She served as administrative secretary for the Dean of the School of Liberal Arts, the Vice President for Student Affairs, and eventually she became the Director of the LBJ Student Center. During that time she earned two degrees from the university. In her time, she witnessed Lyndon B. Johnson sign the Higher Education Act in 1965 and her career spanned 9 Texas State University Presidents. Lillian and the department has established the Lillian Dees and Darla Wood Endowed Scholarship to honor the memory of her daughter and her own legacy in the department. We are grateful to Lilly and the time she devoted to the university, the college, and the department and although we will miss her, we wish her well in her retirement.
