- Reviewed and suggested revisions to over 125 university policies in 2017-2018 and over 80
 policies in 2018-2019, including changes to the faculty sick leave and criminal background check
 policies.
- 2. Reviewed and recommended 52 Faculty Development Leave applications in 2017-2018 and 49 in 2018-2019 for approval. Recommended 10 Workload Release applications in 2017-2018 and 11 in 2018-2019.
- 3. Reviewed and endorsed awards related to the following peer review processes: Academic Computing, Research Enhancement Grants, Nontenure Line Faculty Workload Release, University Lecturers Series, Part-Time Faculty Teaching Awards, and the Piper Professor and Everette Swinney Teaching Awards.
- 4. Revised the Faculty Senate web form to improve communication with faculty.
- 5. Worked with University Marketing to improve access to university logos for academic use.
- 6. Worked with VPFSS to improve the Jones Faculty and Staff dining space. Senator Conroy donated pieces of art that were added to the room.
- 7. Worked with Information Technology to improve communication and increase the amount of faculty input into the decision for the new Learning Management System.
- 8. Worked with the Chief Research Officer to create a plan for continuous improvement of the Institutional Review Board process.
- 9. Worked with the Academic Governance Committee to study the state of shared governance on campus.
- 10. Faculty Senators served as impartial observers in 6 Chair and Director summative reviews in 2017-2018 and 8 in 2018-2019, and chaired committees conducting one Academic Dean summative review in 2017-2018.
- 11. Met with all of the Dean of Education candidates to discuss shared governance issues.
- 12. Charged the Academic Freedom Committee to develop a policy on cyber harassment.
- 13. Formed a task force to review and make recommendations for policies and training to address academic intimidation.
- 14. Supported a Faculty Senate Fellow in 2018-2019, Dr. Araceli Ortiz, whose efforts focused on the Senate theme, Building Community and hosted a program on Strengthening Community through Faculty Diversity in February 2019.
- 15. Advocated with PAAG for increased funding for the Academic Computing Committee to support new technology proposals.
