Senate Chair

- 1) welcomed Senate Liaisons and described the duties and function of the senate and liaisons and our relationship with the administration:
- PAAG meetings and communication with administrative units
- Committees on committees. curriculum, academic freedom,
- Faculty Senate Chair attends Council of Academic Deans
- Peer review and oversight of programs and awards, such as Faculty Development Leave (FDL), and research enhancement, and policies (PPS)
- University Curriculum Committee
- 2) outlined faculty governance at Texas State and the role of liaisons.
- 3) introduced senate initiatives to strengthen community:
  - a. establishing faculty dining room / meeting place
  - b. sponsoring interdisciplinary programs, gatherings, and other activities
- 4) reported that additional 1% Merit pool will appear on February 1 paychecks.
- 5) gave update on sick leave policy. As part of the standard review cycle, ERS audit noted inadequate faculty sick leave reporting in some departments. The law requires reporting and is currently under review to clarify wording. The senate is working on a revision of the policy.
