### PRESIDENT'S ACADEMIC ADVISORY GROUP (PAAG)

- Role of Faculty Senate in Campus Carry planning process

- Campus Safety and the next Master Plan iteration

Campus Safety is an ongoing concern, especially in terms of lighting (both too little and too much). The Associate Provost provided information on the process of hiring a firm to conduct the process of formulating the 2017-22 master plan for our campuses.

• Admissions Standards

Admissions Standards are most accurately reflected in the statistics from the Higher Education Accountability Board, rather than in other online rankings of universities. Of the 27,300 completed applications for admission to Texas State this fall, 14,200 were accepted. This represents approximately a 52% acceptance rate. Progress has been made on the NRU requirement that 50% of first-year students ranked in the top quartile of their high school graduating classes. This fall, the figure reached 48%.
