As Graduate Coordinator I review all graduate applications for admission and determine background (leveling) courses if needed in addition to preparing Master's Comprehensive Exams and submitting Comp Exam reports to the Graduate College. I am also in charge of the Community Health/Fitness Internship Program. This is a full semester experience with a minimum of 480 clock hours spent in a health promotion or fitness related organization. Each semester 15 - 25 students must be placed, supervised and evaluated at the internship site.

I am currently working with a recent Ph.D. graduate (May 2011) on publishing results of our research efforts. I had this student in a Ph.D. course and also served as Chair of the Dissertation Committee. We have two coauthored articles submitted which are under review for publication and two others in development. This has been a very rewarding experience for me in that I am able to serve as a mentor to my student and guide them through the publishing process, and also help make a research contribution to our fields.

The book titled PHILOSOPHICAL FOUNDATIONS OF HEALTH EDUCATION was published by Josey-Bass/Wiley Publishers in 2010. This book is currently used in my Health Education graduate course titled "History and Philosophy of Health Education."

Directly related to teaching I was a contributing author to HEALTH EDUCATION TEKS: A GUIDE FOR TEACHERS. This three part publication was developed to aid in the implementation of the health education Texas Essential Knowledge and Skills (TEKS). The publication identifies connections between TAAS Skills and the activities used to teach the TEKS. Most school districts had chosen PDAS as the method to appraise teachers. Therefore, many principals were asking teachers to identify the TAKS skills being applied or taught in their classes. Many teachers encountered difficulties explaining, in TAKS terms, how their program supports the development of the cognitive skills used in reading, writing, math, science and social studies. Matching the skills with specific activities helped develop an awareness of the cognitive requirements and their relationship to lifetime health knowledge and skills. This publication helps provide a variety of methods with which to apply the health TEKS in the real classroom. The publication for grades 6 -8 was published in 2000, the publication for grades 9 - 12 was published in 2001, and the publication for grades K - 5 was published in 2004.

My book chapter titled "Stress Influences On Accident Incidence" was published by AMS Press in the book HUMAN STRESS: CURRENT SELECTED RESEARCH and I was a contributing author to FOUNDATIONS OF PERSONAL HEALTH published by West Publishing Company. Peer reviewed articles have been published in journals which include the following: Journal of School Health, Social Science Perspectives Journal, Health Education, Texas Association HPERD Journal, Annals of Sports Medicine, Journal of the National Athletic Trainers Association, The Star: Interntional Journal of the Hansen's Disease Center, The Northwestern Lutheran, American Journal of Health Education, and Journal of American College Health.

A significant research project involved a large grant from the Centers for Disease Control and Prevention (CDC). The primary focus of this grant was to help prevent Human Immunodeficiency Virus (HIV) infection and other important health problems. Serving as Project Director and Principal Investigator (PI), we worked to significantly increase the number of colleges and universities that implement effection programs to 1) prevent the spread of HIV infection and other important health problems such as sexually transmitted infections and unintended pregnancy among college students in the state of Texas, 2) prepare school personnel to effectively implement education to prevent HIV infection and other important health problems, and 3) work with relevant public and private sector agencies within the state of Texas to prevent HIV infection and other important health problems for this Centers for Disease Control and Prevention (CDC) grant was: \$1,816,362.00

# STATEMENT OF PURPOSE: Why are you teaching? [max 2160 characters]

I am teaching for two basic reasons: 1) I love to teach, and 2) I have a passion and desire to improve the lives of my students. I grew up in a home where both of my parents were life long teachers. Although they passed away when I was in my early twenties, they had a significant influence on my desire and interest to become a teacher. Teaching gives me satisfaction that is hard to describe. I could not imagine doing anything that would give me the joy and fullfillment that teaching has provided for me the past thirty-six years. I love the opportunity to stimulate the minds of my students. Plutarch said, "The mind is not a vessel to be filled, but a fire to be kindled." One of my primary objectives is to kindle the fire in my students' minds. It is exciting to see those young minds come alive when you can create a positive learning atmosphere by using a variety of teaching methods and actively involving students in the learning process.

Another reason why I am teaching is that the profession of teaching is a self renewal experience. Every semester you have fresh new faces and inquiring minds that are looking for knowledge. You as the teacher are given the opportunity to provide a path to knowledge and to help students develop their critical thinking skills. Teaching is an energizing experience. When you are enthusiastic about the subject you teach and have the skills and abilities to reach your students, teaching becomes magic. It is about opening hearts and minds and changing the lives of those involved in the process. Teaching at Texas State University allows me to have the opportunity to impact students' lives and I feel that is the most important contribution I can make to the next generation of leaders. I am extremely proud of my profession and will forever be grateful that I made the decision to become a teacher.

<u>CURRICULUM VITAE</u>: Other than what has heretofore been enumerated, please indicate the highlights of your teaching career. [maximum 1270 characters]

Over the thirty-one years I have taught at Texas State University I have received consistently high student evaluation scores. The Department of Health and Human Performance (HHP) conducts student evaluations of all faculty in each course during the last two weeks of each semester. The departmental evaluation form is divided into three categories which include Organization, Teaching Strategies and Professional Interactions. Calculations are completed for each class, with a 5.0 being the highest possible score. Over the past thiry-one years my average score has been 4.8. This is the highest average score of any faculty member in our department.

In addition, I was on the original writing team for the Ph.D. in Education proposal which began their work in 1999. The program was approved in 2000 and I have served as a Core Doctoral Faculty member and have taught a Ph.D. level course every year since the first year of approval. I have also served on the Ph.D. Advisory Committee since its inception. To date I have served as chairman for seven doctoral dissertations and as a committee member for six doctoral dissertations.

Steven Furney is a University Distinguished Professor at Texas State University in San Marcos, Texas where he has been on the faculty since 1980. He serves as the Director of Health Education and teaches in the areas of health education and health promotion. His teaching has been recognized with the Everette Swinney Teaching Award, the Texas State University Presidential Award for Excellence in Teaching, Texas AAHPERD College Health Educator of the Year Award, Southern District AAHPERD College/University Health Educator of the Year Award, and the National AAHE College Health Educator of the Year Award.

Dr. Furney has filled many professional leadership roles at the state, district and national levels. In Texas, he served as president for the Texas Association for Health, Physical Education, Recreation and Dance in 1998. In Southern District AAHPERD he was also elected president in 2001. He has served the American Association for Health Education as a member of the AAHE Board of Directors from 2003 - 2006 and through work on numerous committees. The professional associations which he has served have recognized him with the AAHE Professional Service Award, AAHE Health Professional of the Year for Administration, AAHE Fellow Award, Southern District AAHPERD Health Professional of the Year for Administration, Southern District Honor Award, Texas AAHPERD David K. Brace Award, Texas AAHPERD Honor Award, Texas AAHPERD Administrator of the Year Award, and Texas AAHPERD Scholar Award.

Steve Furney was the Project Director and Principal Investigator for a grant funded by the U.S. Public Health Service - Centers for Disease Control and Prevention (CDC): "University Programs for Health Education" (AIDS Consortium of Texas). The grant was funded from 1991 - 1996 with total funding at \$1,816,362.00. He has a textbook published by Jossey-Bass/Wiley Publishers that came out in 2010 in addition to numerous refereed journal articles and book chapters. He also has made over 100 scholarly presentations at the state, national and international levels and was selected as the TAHPERD Scholar for the Texas Association for Health, Physical Education, Recreation and Dance (TAHPERD - the largest state HPERD association in the United States).

As a middle school teacher in the 1970's Steve Furney began his educational journey. From teaching sixth grade students to teaching Ph.D. students he has seen a variety of skills, personalities, interests and potentials in his classrooms. Through his teaching he has been able to influence, inspire and provide a positive impact on the basic knowledge and critical thinking skills of his students.

Dear Dr. Friedman:

I am happy to write this letter of recommendation for Dr. Steve Furney in support of his nomination for the Piper Professor Award. I have known Dr. Furney over five years from both a student and faculty perspective and know him to be an excellent teacher. I fully support his nomination for this award.

*Student Perspective*. Dr. Furney and I first met in 2006 when he interviewed me as an applicant for the Ph.D. in Adult, Professional, and Community Education program at Texas State. From my application, Dr. Furney learned I was from Knoxville, TN, and since he completed his doctorate degree in School Health at the University of Tennessee and was familiar with the area, he began the interview by asking about Knoxville. This immediately put me at ease. The interview was more like a comfortable conversation between new acquaintances rather than the tense, formal interview I had expected. Dr. Furney always makes the special effort to make those around him comfortable, which is one of the main reasons he is such a respected and effective teacher.

As a doctoral student enrolled in ED 7323 Community/Organizational Leadership and Management, I was also impressed with Dr. Furney's classroom performance. The subject area of leadership was a perfect topic for Dr. Furney as he was always well organized in class and expertly led the large group discussion sessions. Dr. Furney's obvious extensive background knowledge and interest in the subject matter made the course not only informative, but made students curious and encouraged active participation. Dr. Furney's assignments were meaningful, creative and relevant, and helped link the theoretical and practical aspects of leadership presented in class. I remember on the first night of class he had us list qualities we felt important for a good leader. On the last night of class, we repeated the exercise and compared the two lists. I was surprised at how my views of leadership had advanced over the semester. I have since utilized this same "before and after" review technique in my own teaching adapting it for student review of medical documentation. I find it to be an excellent tool for demonstrating changes in student learning.

I was fortunate to have Dr. Furney not only as an instructor in the Ph.D. program, but also as my graduate advisor. He and I met early in the first year of the program to discuss my dissertation ideas and it was no surprise that he later agreed to work with me as Chair of my dissertation committee. I use the phrase "work with me" specifically because that is reflective of how he and I approached the dissertation project, it was truly a collaborative effort. Despite serving as Chair of five other dissertation committees and participating as a committee member on four others, Dr. Furney always made himself available to me. He was always encouraging and quick to respond. I will never forget him referring to my numerous draft reviews as his "recreational reading." Dr. Furney's easy style of mentoring was the perfect complement to my "type A" personality. With Dr. Furney's teaching and guidance regarding dissertation development, my dissertation was completed in less than two years without the disagreements. arguments, and disasters that one frequently hears about regarding dissertation projects.

*Faculty Perspective*. Since my graduation from the Ph.D. program, Dr. Furney has continued in the role as my teacher in the area of scholarly work. As junior faculty, I was at first unsure about the process of generating individual articles from my dissertation. With his experience and success with peer-reviewed publications, Dr. Furney has been an excellent resource teaching me how to tease out different aspects of the data. Under his guidance, we have two co-authored articles under review for publication and two others in development. It is an honor to work with him at this collaborative and collegial level.

I consider myself very fortunate to have been assigned as one of Dr. Furney's interviewees in 2006. From that initial meeting, I gained not only admittance into the Ph.D. program, I also gained an outstanding role model in teaching, a mentor, and a trusted colleague. Reflecting on my experiences with Dr. Furney over the past five years, at all times while he has been helping me achieve my scholarly goals, he has also been teaching me how to be a better teacher/mentor to my own graduate students. Dr Furney has a special talent for teaching students when they are not even aware they are being taught.

I fully support Dr. Furney's nomination for the Piper Professor Award. As this letter demonstrates, his excellence in teaching and mentoring extends well beyond the classroom and continues long after graduation. The Piper Professor Award represents outstanding achievement in teaching and I can think of no other professor more deserving of this recognition than Dr. Steve Furney.

Dear Committee Members:

Any Dean-ship carries with it certain responsibilities and delights. The one thing that combines both categories best is endeavoring to make sure that outstanding faculty get the recognition that they deserve. Such is my task and my privilege with this letter in support of Dr. Steven Furney for the prestigious Minnie Stevens Piper Award. To be sure, Dr. Furney has been honored for his teaching, research, and service many times over his more than 35 year career, but the term Piper Professor is one that he seems ideally suited for. Among other reasons for me to say this is that his first major, university-wide award for teaching was over two and a half decades ago! That he has maintained the level of excellence to which his students attest to this day is remarkable and deserving of the award almost in itself.

I know that you will have access to Dr. Furney's résumé, so I will not go into detail about his activities other than teaching except to point out that he is a talented and productive scholar, with dozens of books, chapters, and journal articles to his credit, as well as scores of refereed and invited scholarly presentations. His reputation as a scholar and professional in his field is further indicated by the very heavy professional service load that he has carried over the years. Clearly, he is one of those people that are asked to take offices and oversee tasks time and again because of his effectiveness and his values. Such people are invaluable in professional associations and they rarely come in a package with excellent scholarship and teaching simply because most people cannot pull off the amount and variety of work required for such a record. This is the essence of Dr. Furney's uniqueness - he just seems to work harder and more effectively than most other people. I have only spoken so far about his service off campus—on our campus, his service is even more prodigious. He is a Faculty Senator for the College of Education and has been for years, he serves on countless university committees, is very active at the college level, and is a stalwart in his very busy department. It is hard to say enough about his value to Texas State.

Steve Furney teaches at every level from undergraduate to doctoral students. He advises student research at the master's thesis and the dissertation levels. He supervises internships, he teaches any course needed in his program, and he consistently gets the highest of high evaluation scores from his students. He participates in curriculum development and governance for the department and program, as well as for the doctoral program, which is housed in another department altogether. He has the respect and admiration of students and colleagues alike and is an acknowledged "professor's professor." His many teaching awards attest to the esteem in which his students hold him, but also to the fact that he is someone for faculty to emulate. That is the point of awards like the Piper and you would be proud to have Dr. Furney as one of your awardees.
