Research Enhancement Program (REP)



All full-time Texas State faculty members with full-time, continuing nine-month academic appointments are encouraged to apply for Research Enhancement Program grants. Tenured, tenure-track, and clinical/practice faculty who hold the rank of assistant professor, associate professor or professor may apply as principal investigators (PIs) or co-investigators (CIs). Nontenure line senior lecturers may apply as co-investigators with eligible PIs. This is an internally-funded competition; individuals are eligible to apply for a maximum of \$8,000; two or more eligible faculty working together on one project may request a maximum of \$16,000. Final recommendations for funding of Research Enhancement Grants are made by the University Research Enhancement Committee through the Faculty Senate. Applications are due by 5 pm Tuesday, October 13. Apply via the Texas State Internal Proposal Online Submission page.

National Council of Faculty Senates Conference

Highlights from the National Council of Faculty Senates (NCFS) Annual Virtual Meeting, September 18/19, 2020

Senate Chair Bezner attended the NCFS virtual meeting and engaged in discussions about faculty role in institutional budget decisions, impact of COVID on faculty and the ways in which the NCFS can provide resources and support, shared governance and the degree to which shared governance has impacted faculty during COVID and ways to enhance shared governance, and the ways in which higher education can fight racism. The Faculty Senate intends to have follow up discussions on these topics and will share additional information in the future.
