2019-2020 Faculty Senate Selected Accomplishments

This academic year was busy! The Faculty Senate:

- Approved a Nontenure Line Faculty Career Path Proposal for consideration by the administration.
- Included faculty in the Honors and University Colleges as faculty voters in their home colleges, enabling these faculty to participate in Faculty Senate activities.
- Worked with Dr. Scott Bowman, Special Assistant to the Provost for Diversity and Inclusion, to require diversity and inclusion training for all faculty search committee members and Dr. Bowman presented the Toolkit and Best Practices for Inclusive Excellence in Faculty Hiring and Retention.
- Approved resolution supporting the use of Affordable Learning Materials, including Open Educational Resources (OER) at Texas State.
- The 60th Senate endorsed the Chicago Statement on Academic Freedom. The 61st Senate requested that President Trauth endorse the statement on behalf of the university.
- Reviewed and endorsed awards related to the following peer review processes: Research Enhancement Program Awards, Nontenure Line Faculty Workload Release, University Lecturers Series, Part-Time Faculty Teaching Awards, and the Piper Professor and Everette Swinney Teaching Awards.
- Advocated for changes to the AA/PPS 04.02.32 <u>Faculty Grievance Policy</u>, which have been made, and for gender neutral language in university policy statements.
- Requested the Academic Governance Committee draft a new Personnel Committee policy, which is in the process of being completed and reviewed.



Fall Application Deadlines

Faculty Development Leave: by September 15, notify your department chair or school director if you intend to apply. Applications are due October 1. Apply via the Faculty Requests application system, which will open August 21.

Nontenure Line Faculty Workload Release: by September 15, notify your department chair or school director if you intend to apply. Applications are due October 8 via the Faculty Requests application system, which will open August 21.

Piper Professor Nominee: applications are due September 25. The Faculty Requests application system will open August 1.

Research Enhancement Program (REP): applications are due October 10. Apply via the <u>Texas State</u> Internal Proposal Online Submission page.
