

2020-2021 Faculty Senate Accomplishments

Theme: Advocating for Justice and Transformation

- Reviewed and endorsed awards related to the following peer review processes: Research Enhancement Grants, Nontenure Line Faculty Workload Release, University Lecturers Series, Part-Time Faculty Teaching Awards, and the Piper Professor and Everette Swinney Teaching Awards.
- Reviewed 65 Academic Affairs and University Policy and Procedure statements.
- Contributed to efforts to enhance environmental sustainability on campus by supporting Dr.
 Tina Cade's 2020-2021 Senate Fellow project to create an environmental sustainability "road map," including a list of steps the university and its members can take to improve sustainability.
- Cosponsored the Academic Freedom Committee and Philosophy Dialogue Series.
- Endorsed required diversity training for faculty hiring, faculty enrichment, and department participation.
- Distributed two surveys to faculty to ensure our collective concerns and voices were heard regarding personal health, safety, and course modality options during the pandemic.
- Continued to work on drafts of the NLF Teaching Faculty Appointments and Personnel Committee policies and finalized the Academic Freedom policy.
- Advocated for an additional year's tolling of the tenure clock.
- Advocated for early semester updates from the Registrar to notify faculty of students who add/drop courses prior to census day.
- Participated in Restorative Justice sessions.
- Prepared and submitted recommendations to improve faculty morale to university administration.

2021 Faculty Perceptions of Academic Administrators



The Faculty Senate has completed the annual Faculty Perceptions of Academic Administrators Survey and the <u>summary document</u> is available on the senate website. The senate appreciates the assistance of the Office of Institutional Research in this effort. The data sets can be accessed using the links in the summary document. As per an agreement with the Provost, the written comments will be made available for 90 days. Rather than this period comprising the summer months, the comments will be posted via the link noted in the summary document between September 1 and November 30.

Fall Application Due Dates



<u>Piper Professor Nominee</u>: applications are due September 17. The Faculty Requests system for Piper applications will open July 30.

<u>Faculty Development Leave</u>: by September 15, notify your department chair or school director if you intend to apply. Applications are due October 1 via the Faculty Requests application system, which will open August 20.

<u>Nontenure Line Faculty Workload Release</u>: by September 15, notify your department chair or school director if you intend to apply. Applications are due October 8 via the Faculty Requests application system, which will open August 20.

Research Enhancement Program (REP): applications are due early in October. For specific deadline and to apply, visit the <u>Texas State Internal Proposal Online Submission</u> page.

Faculty Senate Fellow

The senate has chosen Dr. Sarah Angulo, Senior Lecturer, Department of Psychology as the 2021-22 Faculty Senate Fellow.

Sarah's fellowship project will focus on campus-wide facilitation of mentorship and career development opportunities for non-tenure line faculty (NLF), a group that tends to be disproportionately composed of underrepresented minorities and women. This project has three parts. First, a pilot program of N LF mentoring and career development will begin in the Psychology Department in fall 2021. Second, key stakeholders across our university will be surveyed to assess their mentoring and career development needs. Third, equipped with these survey results, as well as knowledge gleaned from the fall pilot program and benchmarking data, Sarah will provide workshops in spring 2022. These workshops will be available to the university community in San Marcos and Round Rock. The goal will be to share knowledge gained and best practices for NLF mentoring and career development.

The Faculty Senate's Environment and Sustainability Committee announced the Green Cat Challenge Awards to recognize university community members, departments, and organizations for exceptional commitment to sustainable practices and environmental stewardship at Texas State University.
