

This year Dr. Fields took over as director for the Center for Research, Public Policy and Training. In addition to work on several transportation grants, the Center hosted two events this year. Last fall, the Center co-hosted the first annual Transportation Policy for Central Texas Symposium series with the Texas Transportation Institute, the University of Texas Center for Transportation Research, and Bike Texas. The Center also co-hosted the Transportation Beyond Oil Symposium with the Carnegie Endowment for International Peace and the University of New Orleans Transportation Institute in Washington, DC.

In addition to the work with the Center, Dr. Fields has been active in research. He co-edited the just released *Transportation Beyond Oil* by Island Press. He has continued to present research findings at national conferences (ASPA in New Orleans and the Active Living Research Annual Conference in San Diego). He was also awarded a travel grant by the Center for Spatial Studies at the University of California Santa Barbara to be an invited participant in the Spatial Thinking Across the College Curriculum Specialist Meeting. Dr. Fields also joined the Childhood Obesity Intervention Cost Effectiveness Study stakeholder team. He traveled to Harvard University in June for the annual work group meeting. Dr. Fields will teach several sections of POSI 5321 (Introduction to Public Administration/Public Policy) this upcoming year and looks forward to engaging with you in 2013/2014.

In 2012, Dr. Longoria had three articles accepted for publication including "Are We All Equal at Death?: Death Competence in *Municipal Cemetery Management*. Dr. Nandhini Randarajan

Dr. Nandhini Rangarajan was promoted to the position of Associate Professor and was granted tenure by the Board of Regents, Texas State University System in Spring 2013. In the spring semester, Dr. Rangarajan published a case study about San Antonio's greening initiatives with Dr. Dianne Rahm. This case study entitled "San Antonio's Mission Verde and Leading by Example Initiatives" was published in a book called *The Greening of Public Management*.

Dr. Rangarajan' s first book – co-authored with Dr. Patricia Shields entitled *A Playbook for Research Methods* -was published in the Summer of 2013. This book explains difficult concepts related to research using intellectually accessible metaphors (American football, organizing a kitchen, a mother comforting a crying baby, paint-by numbers, juggling etc.). It provides important research and project management tools for students who embark on their first major research projects.


## A Playbook for Research

Methods

A Student-focused Research Guide by
Texas State MPA faculty and students

The new publication, hitting bookshelves and classrooms fall of 2013 is a collaborative project between two Texas State MPA faculty: Dr. Patricia Shield, Dr. Nandhini Rangarajan and utilizes the scholarly work of MPA graduates - both past and present.

This spring I, Curtis Leeth, had the opporunity to work with a draft version of A Playbook for Research Methods in POSI 5334 - Problems in Quantitative Research under the tutelage of Dr. Shields. The *Playbook* is quite unlike any research metholodgy textbook I have encountered - heck any textbook really. This is because the Playbook is both straightforwardly written and details the research process that former Texas State MPA graduates went through to produce their own ARP. The multitude of ARP examples gives a Texas State MPA student a level of intimacy and familiarity with the program and its student scholarship usually unachievable by graduate programs. This level of intimacy allowed me to both imagine these previous students in my position in years back, a comforting thought, and also provided templates within which to imagine my own research. All this is, of course, in addition to the valuable understanding gained from the book on of concetual frameworks in general. Taking the lessons from the book, I gained a new vocabulary and understanding with which to discuss the ARPs our class read, in their entirety, for the course. The *Playbook* combined with the *Step-by-Step* research approach of Dr. Shields to writing research papers equipped me with both the abstract conceptual understanding and a gameplan with which to tackle my own ARP.



I cannot reiterate enough, A Playbook for Research Methods is truly a product of the Texas State MPA program. The football playbook approach is inspired by former MPA students of athletic backgrounds and utilitizes a multitude of former Texas State MPA Applied Research Projects (ARP) as examples and source material. The Playbook not only has immense interdisciplinary potential as a research guide, but will more over serve as a vehicle to showcase the vast collection of high quality graduate work of the MPA program. Reading in full the many ARPs showcased in the Playbook heightened my awareness of the quality of previous student scholarship in the program. This awareness is not over-awing, however, because of the research tools found in the *Playbook* and *Step-by-Step*. These are the same tools used by these former MPA students and the same tools with which I will utilize in my own ARP, which I begin in earnest this fall semester.

The fine scholarly and conceptual work of Drs. Patricia Shields and Nandhini Rangarajan cannot be praised enough but it is the ARPs of Texas State MPA students that are the heart and soul of the new publication. This heart and soul makes the *Playbook* a special milestone in the continued growth of the Texas State MPA Program.

#### Texas State MPA Graduate Wins National Award

Deborah D. Tucker (1981)

In 2012, Deborah D. Tucker, Executive Director of the National Center on Domestic and Sexual Violence, won the national National Association of Schools of Public Affairs and Admnistration Alfred M. Zuck Public Courage Award for her decades of courageous and dedicated campaigning to reduce violence against women. Deborah's life-long mission began as a student volunteer at the Austin Rape Crisis Center in 1974, where she worked with survivors/victims under dangerous and threatening conditions (often surrounding testimony issues). Perhaps more impressively she took on male bastions of the Texas Legislature and the Texas Police departments to change time honored Texas mores and perceptions. At the time, she often faced not only unfriendly, suspicious legislators but also hostile crowds. It was not uncommon for Deborah to fear for her safety and request an escort from the Capitol Police after public testimony.

One of the keys to successful domestic violence resolution is police organization's recognition of the domestic violence problem and training officers to deal with such situations. Deborah was essential during her work in the 1970s and 1980s in changing the culture of police departments across Texas from the Capitol Police to rural sheriffs of west Texas despite resistence and outright hostility.

Deborah Tucker has gone on to achieve national and international recognize for the work she has done to end doestic and sexual violence. Her recent award is only the latest in her life long achievements. The Texas State MPA department is honored to call her an alum and sends her a heartily congragulations.

#### W. Brandon Tanous (2007)

Since graduation Brandon joined the Chief Auditor's Office at the Texas Commission on Environmental Quality where he conducted external and internal audits as a audit project manager. In September 2010, Brandon joined the Texas Department of Public Safety Chief Auditor's Office where he conducts internal audits and advisory services as a senior internal auditor. Brandon has become a Certified Internal Auditor (CIA), a Certified Government Auditing Professional (CGAP), Certification in Risk Management Assurance (CRMA), and a Certified Law Enforcement Auditor (CLEA). Brandon has co-authored a case study in the Association of Certified Fraud Examiners Bribery and Corruption Case Book: A view from under the table. Brandon was recently featured in the Institute of Internal Auditor's Internal Auditor Magazine article "Top 20 Under 30". Brandon recently finished a two year appointment as a Commissioner for the Travis County Emergency Services District No. 14. Brandon has conducted various trainings and presentations at the International Law Enforcement Auditors Association Conference (2011), Texas State Auditor's Office Conference and the IIA Southern Regional Conference (2012).

#### Cameron Freberg (2011)

"I am currently working at Austin Energy as a Conservation Program Specialist in the Electric Vehicles & Emerging Technologies department. One of the projects I am working on is a US Department of Energy grant known as the "Central Texas Fuel Independence Project" that is focused on the integration of electric and natural gas vehicles into the central TX market. Also, while writing the grant proposal for the U.S. DOE, I did rely on the notebook method that Dr. Shields developed. This new project is built upon a previous grant effort known as the Texas River Cities plug-in electric vehicle initiative. This was a 500+ page comprehensive report that outlines all of the essential elements to prepare for electric vehicles. The executive outline and full report can be found at texasrivercities.com."

#### Delaina Toothman (2011)

Delaina is currently working on her doctorate at the University of Maine. Additionally, she is doing consulting work for several Maine State Elected Officials as well as the Maine Republican Party. On the side she is writing materials for Oxford Publishing for online instruction in Political Science.

#### Jason Irle (2011)

Jason was hired in May 2011 by Brauntex Performing Arts Theatre Association Inc.; three days after graduation from the MPA program at Texas State University. Jason has used many of the tools the MPA program offers namely the Notebook method and skills learned in the public finance portion of the program. Over the past two years the Brauntex has increased its programming capacity and double audience participation. #### **CPM Goes International!**

Texas State University's William P. Hobby Center for Public Service is preparing to start a pilot Certified Public Manager (CPM) Program in the countries of Estonia, Latvia and Lithuania. Completion of the Program would result in public and not-for-profit managers in those countries receiving the designation of Certified Public Manager. In May 2013 faculty from the CPM program traveled to Latvia and Lithuania to work out details for beginning the pilot program in the Baltics. Several international faculty members were identified and have agreed to participate, building upon an already 15-year relationship. At the present time about a dozen graduate students/practitioners are being chosen to participate from both the Baltic countries and the US. These students will all participate in the one year CPM Program which is scheduled to begin sometime in September 2013.
