





TRLA provides free legal services to residents in 68 Southwest Texas counties.

TRLA serves about 23,000 clients each year. However, more than 2.6 million residents of Southwest Texas are considered eligible for TRLA services, a ratio of almost 21,000 potential clients per legal aid lawyer.

TRLA attorneys specialize in more than 45 practice areas, including **disaster**, family, employment, foreclosure, bankruptcy, subsidized housing, farmworker, civil rights, and environmental law. Texas RioGrande Legal Aid

- Prederally declared disasters in our service area since 2002:
 - Hurricanes Katrina, Rita, Dolly, Alex and Harvey
 - Wildfires in Central Texas in 2011
 - Multiple storms, tornadoes, and flooding affecting El Paso, Central Texas, Laredo, the Lower RioGrande Valley, the Coastal Bend, and the Golden Crescent/Victoria region
 - Winter Storm 2021
- Provided legal assistance to thousands of disaster survivors
 - Legal advice
 - Document preparation
 - Representation before administrative agencies
 - Representation in JP, state, and federal court

Why Disaster Survivors Need A Lawyer

- Disaster survivors need food, water, shelter—and an attorney
- Many legal issues arise, or are worsened by disasters, such as disaster benefits, landlord tenant, consumer fraud, insurance, public benefits, estates and property, and tax issues
- Marginalized communities are especially vulnerable after a disaster

Legal Needs After a Disaster

Legal Needs After a Disaster

1 TO 6 WEEKS AFTER EVENT

- Landlord-Tenant questions
- Present insurance claims, proactive steps to maximize coverage, flood insurance
- Apply for FEMA assistance (temporary housing, home repair/replacement, other needs)
 - Apply for SBA Disaster Loans to individuals, Disaster
 - Replace documents (ID, driver license, SS card, EBT, custody, immigration, deed, etc.)
 - Referral to community services (Red Cross, local government, religious, etc.)
 - Apply for or redirect unemployment, TANF, SNAP/Food Stamps, Medicaid, SSI benefits
 - Wage/Labor Theft Redress
 - Respond to public agency requests for emergency rule modifications on health, human services, and utility concerns.

Housing Issues After Disaster: Termination of Tenancy

- If the rental unit is "as a practical matter totally unusable for residential purposes" as a result of a casualty loss and the tenant is not at fault, either the landlord or the tenant can **terminate a tenancy via written notice** any time before repairs are completed.
 - A tenant is entitled to pro-rated refund of rent after moving out and the same right to a refund of security deposit as if the lease did not terminate early
 - A landlord must go through the judicial eviction process to remove a tenant who refuses to leave after a landlord's termination, including by issuing a valid Notice to Vacate before filing suit
 - After landlord termination under 92.054, a court must not evict if the landlord cannot show that the unit was "as a practical matter totally unusable"

Tex. Prop. Code § 92.054(b)

Housing Issues After Disaster: Repairs & Remedies

• A tenant can file a lawsuit in justice court to order repairs of conditions that threaten health and safety, and must show that the tenant was current on rent when they sent the required notices of repair (two requests or one via Certified Mail), and the landlord did not make a diligent effort to repair/remedy the condition during a reasonable time after receiving notice

Tex. Prop. Code §§ 92.056, .0563

 If a condition results from an <u>insured</u> casualty loss, the time for a landlord to repair the condition does not start until the landlord receives insurance proceeds

Tex. Prop. Code § 92.054(a)

Housing Issues After Disaster: Lock-Outs & Utility ShutOffs

- •Landlords may intentionally lock a tenant out* and/or interrupt/cause the interruption of utilities **only if reasonable for**:
 - •Bona fide repairs, construction, or emergencies
 - Tex. Prop. Code §§ 92.008, .0081
- A tenant may seek a writ of reentry or writ of restoration of utility services
 - Tex. Prop. Code § 92.009, .0091

*Lockouts may also be allowed after abandonment or when a tenant owes rent, but only if landlords **follow all proper procedures, including the terms of the lease**

Housing Issues After Disaster: Paying Rent

 If the unit becomes partially unusable after a casualty loss, tenants may obtain a rent reduction <u>only</u> via county/district court judgment (<u>not</u> justice court), unless the lease says otherwise

Tex. Prop. Code § 92.054(c)

- Until the lease terminates, a tenant must pay rent, regardless of the condition of the premises
 - Some exceptions: utility reinstatement costs and certain repairs
- Tenants who are unable to pay rent may qualify for protection from eviction under the CDC Order and the Texas Supreme Court's 34th E.O.
 - Rental assistance is available through Texas RentRelief.com and the Texas Eviction Diversion Program (TEDP).

Title Disputes and Attempted Evictions

- May not have jurisdiction in divorce, slander or defamation, trial to title of land, or enforcement of liens on land, and suits to recover penalties, forfeitures, and escheats on behalf of the state...
- Government Code Sec. 27.031

Disaster Assistance

- Federal Emergency Management Agency
- FEMA IHP Housing Assistance for owners and renters
- Type of IHP Financial housing assistance
 - Rental assistance
 - Lodging Expense reimbursement
 - Home repair
 - not intended to return home to pre-disaster condition
 - Home replacement
 - If home destroyed
 - Not intended to cover FULL cost of replacing home
- Appeals begin as soon as FEMA inspections are complete and peaks about 60 days after the first deadline

FEMA

- Benefits are not taxed
- Benefits decisions do not affect your other means-tested public benefits

FEMA Housing Eligibility

- Home is in declared disaster area
- Can't live in home now, OR Can't get to home due to disaster, OR need repairs to make it habitable again.
- Household member is US Citizen, LPR or Qualified Alien
- Insufficient or no insurance coverage (or can't get paid in time and agree to repay FEMA)
- Ownership required for home repair or replacement, but not temporary housing assistance.

FEMA Housing

- Using Rental Assistance and Continued Rental Assistance
- USE:
 - to rent another place from private owner
 - House
 - Apartment or Duplex
 - Short-term motel or hotel
 - but check with FEMA for how long and how to document
- Do NOT Use:
 - for public housing or Sec. 8 (already affordable without FEMA money)
 - to stay with friends or family members

- Types- SBA Dependent and non-SBA dependent
- Ability to repay
- Interest rates can be better than other loans
- Duration of Assistance
- Read carefully
 - Flood insurance requirements
 - Security interest in home for some loans
 - Who you hire to do the repairs

Getting Disaster Assistance

If your property has been damaged by the storm, you should file a claim with your insurance and then apply for assistance through the Federal Emergency Management Agency (FEMA). The application process through FEMA will also include consideration for Small Business Administration (SBA) disaster loans, which are available to both individual homeowners and business entities alike. **You do not have to have insurance to receive FEMA Disaster Assistance.**
