New Business

- 1. NLF Initiatives at other universities (Janet)
 - a. Discussion with Jim Woosley, Texas A&M University

b. Mark Clark, University of Houston. UPDATE: Janet visited with Jim Woosley from Texas A&M about this topic. Jim stated at Texas A&M there was not enough collegiality between NLF and Tenure track faculty. He attended a meeting where Michele Conro spoke about NLF initiatives at Texas State University which encouraged him to begin the discussion process at Texas A&M. He stated titles at Texas A&M created problems, i.e. Lecturer. Texas A&M converted Lecturer, etc. to current verbiage. Academic Professional Track faculty (APT). They use [adjective in front] titles such as *Research or Clinical* Assistant, Associate and Professor for NL faculty, etc. These policy changes created a different environment with faculty on their campus. This approach is occurring with a career path. Texas A&M suggested tenure track faculty advocate for implementing this process at Texas State. Janet will get Texas A&M promotion information related to their APT faculty and provide an update at our next committee meeting.

Mark Clark, University of Houston. **UPDATE**: Janet has not heard back from mark, yet.

- 2. **Cupa data** (Janet): Janet wants the committee to review the attached data and determine what issues arise from our review (comparing salaries, etc.). We will visit with Dr. Thorne to address our concerns related to data aggregated in the CUPA file. Eric (VP of Finance and HR) shared: Every year the President's Cabinet has a couple million dollars of discretionary funding to allocate across the campus. The decision this year was to create permanent lines for faculty across the university in the various colleges. Currently, Deans have been asked to prioritize the temporary faculty lines they would like to be made permanent with these funds.
- Planning for Fall Reception (Kevin). UPDATE: Kevin recapped the past two years (see attached document) for this event. Our questions: How do we include Round Rock (host on this campus)? Additionally, we have tentatively selected Wednesday, September 25, 2019 from 5:00 7:00 pm. to host this event in the Reed-Pharr Room. Valerie will help to secure this date and time for the 2019 Fall NLF Reception.
- 4. Academic Freedom Committee (Renee). UPDATE: The committee is working on a policy related to cyberbullying. Dr. Luisi is interested in NLF feedback.
