The following must be included with your School of Music application in order for your application to be pre-screened by the SRT faculty for interview consideration. > 90 second video file or link > 3 letters of recommendation *Note: Letters should reflect positively on your musical abilities and math/science background, give information regarding your audio experiences or personal qualities that can assist in the assessment process, and are from credible sources (teachers, job supervisors, etc.). > Requested transcripts based on your admission level – freshman or transfer (either HS or college, if applicable). *Transfer students who have not taken a higher-level math class must also provide a copy of your high school transcript.
Evaluation of application materials will determine if you will audition as a SRT applicant. You will be notified whether or not you will be granted an interview during step #3. If you are not invited to interview, you will not be considered for admission to the Sound Recording Technology program during step #3. Therefore, You must notify the School of Music prior to your scheduled audition date indicating whether or not you wish to keep your audition date and be considered for a music degree program other than Sound Recording Technology (other options: Bachelor of Arts, Bachelor of Music – Music Studies, and the Bachelor of Music – Performance). 3) Complete a Music Audition and SRT Interview.	

Admission to the School of Music is determined by the applied faculty's evaluation of your audition.

Admission to the SRT program is determined by the SRT faculty's evaluation of your interview and is contingent upon your acceptance by the applied faculty.

Generally, the application process is completed in the Spring semester for enrollment the following Fall semester. The application and supporting materials must be received a minimum of 30 days before the applicants audition date. On average, we process between 60 and 120 applications for the 15 positions available. Students are notified by the end of March/beginning of April as to their admission status.

Spring admission is contingent upon an appropriate academic background and a current student dropping out of the program or graduating. The application and supporting materials are due by October 1 – see our website for more info. Often, we do not know whether space is available in a Spring class until late registration begins in mid-January. On average, we process between 5 and 10 applications for Spring admission. Spring admission is rather rare.

Applicants must be prepared to study music at a university level. This means you have studied an appropriate instrument or voice part formally for several years prior to applying. *Note:* Some instruments and/or performance styles are not available for study at Texas State University. Check the School of Music website for appropriate instruments and performance styles.
