Explanation

The accompanying schedule summarizes the proposed reduction in Tuition and Fee Rates for the Lamar State Colleges, effective the Fall 2019 semester.

To help alleviate the taxpayer funding disparity of the Lamar State Colleges, the Texas Legislature and the Governor increased state formula funding by \$17.3 million for the biennium.

The Lamar State Colleges, the only 2-year colleges serving the Southeast Texas community, rely exclusively on state appropriations and tuition and fees to fund its operations, unlike other 2-year colleges in Texas who are provided additional taxpayer support through ad valorem taxes.

Due to the disparity in tax-supported funding, the State Colleges have relied on tuition and fees. This over-reliance yields tuition and fee rates at the State Colleges more than twice that of its regional community colleges.

A key legislative priority of the Board of Regents, the Chancellor and the Presidents of the Lamar State Colleges was to seek increased state formula funding from the 86th Texas Legislature at a level to provide funding on par with the regional community colleges.

The increase in state formula funding provided will allow the Board of Regents to reduce Mandatory Tuition and Fees by approximately 25% and reduce the tuition and fees for Dual Credit / Early College High School to \$50 per Semester Credit Hour.

These reductions in designated tuition and fee rates at the Lamar State Colleges will increase access to higher education for the citizens and employers in this region, a region that is key to the economic prosperity of Texas.

LSCPA: Designated Tuition Rate for Credit Courses Provided for Incarcerated Persons

The Designated Tuition rates for Credit Courses provided by Lamar State College – Port Arthur to the Texas Department of Criminal Justice and the Federal Bureau of Prisons for the Academic Years 2017, 2018 and 2019 be ratified.

Explanation

Lamar State College – Port Arthur (LSCPA) contracts with the Texas Department of Criminal Justice (TDCJ) and the Federal Bureau of Prisons (FBOP) to provide credit and non-credit courses.

LSCPA negotiates separate agreements with TDCJ and FBOP to provide these educational services on-site at the prison. Given the decreased cost associated with these services being provided off-site, LSCPA waives all fees except the Computer Use Fee. Additionally, the Designated Tuition Rate was historically contracted at \$0 per Semester Credit Hour but was increased to \$15 per Semester Credit Hour for Fiscal Year 2019.

LSCPA is requesting ratification of the reduced designated tuition rate for Fiscal Years 2017, 2018 and 2019.

TSUS Rules & Regulations (Chapter 4, Section 2.2(23)) provides Presidents the authority to waive fees for students who enroll in "off-campus" courses.
