TSUS: Appointment of Dr. Jaime R. Taylor, as President of Lamar University

Dr. Jaime R. Taylor be appointed as president of Lamar University, with tenure as a full professor in the College of Electrical Engineering, with a start date of no later than July 12, 2021.

Explanation

Dr. Taylor was selected following a national search, co-chaired by Regents Scott and Montagne, with active participation by Regents Austin and Tinsley. He is currently provost and senior vice president for academic affairs of Marshall University in Huntington, West Virginia, which has a student enrollment of nearly 13,000. In this role, he has led successful initiatives to increase first-year retention and graduation rates and align academic programs with critical community and workforce needs.

Dr. Taylor previously served as interim provost and vice president for academic affairs at Austin Peay State University in Clarksville, Tennessee, where he spent most of his career as a faculty member in the Department of Physics and Astronomy.

Dr Taylor earned an associate of applied science degree in Industrial Engineering Technology from Nashville State Technical Institute, a bachelor's degree in Physics and Mathematics from Austin Peay State University, and a master's degree and Ph.D. in Engineering Science from the University of Tennessee Space Institute.

In his own words, Dr. Taylor is "eager to learn from the faculty, staff, students, alumni, and members of the Beaumont community of their vision for what is next for Lamar University and to determine how we can work together to ensure that the vision becomes a reality." He is also "extremely pleased to see that Lamar University's Strategic Plan reflects [his] passion for student success, retention, and creating career-ready and life-long learners who can find success after they graduate."

Explanation

The accompanying schedule summarizes the proposed reduction in Tuition and Fee Rates for the Lamar State Colleges, effective the Fall 2021 semester.

A key legislative priority of the Texas State University System was to seek to second increase to the state funding formula for the Lamar State Colleges from the 2021 Texas Legislature. That increase is needed to further reduce tuition and fees to be on par with the regional community colleges. The 2021 Texas Legislature and the Governor supported this request, increasing the state formula funding rate for the State Colleges by 40%.

The increase in the state formula funding rate will allow the Board of Regents to further reduce Mandatory Tuition and Fees, provide \$10 per contact hour instructional material scholarship and a \$5 per contact hour scholarship on dual credit tuition.

This proposal, in combination with the previous reduction, will result in an average reduction in mandatory tuition and fees, and book charges of 47%. Under this proposal, a student can obtain a 2-year degree for \$7,080 or less.

The efforts of the Texas Legislature will allow the Lamar State Colleges to increase access to higher education for the citizens and employers in this region, a region that is key to the economic prosperity of Texas.
