#### Why?

The MAcy Program enabled me to become more skilled in research and encouraged me to participate in groups and class discussions. I also learned to talk in front of a group of 10-20 students and this enhanced my public speaking skills. Finally, the ethics course helped me understand how to analyze situations and apply ethical understanding before making a crucial ethical decision.

Other comments or thoughts you would like to share with us:

I would love to thank all my professors for helping me to have a deeper understanding about the accounting profession. I learned a lot during the past 12 months and I hope I will be able to apply the knowledge in my career.

My one major complaint with the MAcy program here at Texas State is the requirement that ethics can only be taken in the last semester before graduation. It's a problem for both applying and taking the CPA exam. I know people from Texas A&M who have taken all parts of the CPA exam and received their CPA license before graduating and starting working full time. I would much rather take the CPA exam while in school than working full time due to the fact that I will have more time to devote to studying for the exam as well as that information learned in class for the exam will be fresh in my memory when taking it
