As a facilitator in the student learning processes, I pay attention to classroom and interpersonal dynamics and have a strong focus on building a learning community with emphasis on integrity, civility, professionalism, and collaboration. This provides an environment in which students feel safe to take risks and make mistakes to promote their learning as well as expand their personal and professional growth. I attempt to convey the importance of experiential or applied learning by not overemphasizing grades, rather, highlighting the amount and depth of their improvement in clinical service delivery.

My overall teaching philosophy is based on two principles, which are supported extensively in research literature: (a) active student learning strongly influences student-learning outcomes; and (b) assessment procedures strongly influence student acquisition of knowledge. To that end, I follow a number of practical principles in teaching course material, including clinical skills. I communicate a clear sense of direction and purpose with the acquisition of clinical skills and its cumulative nature. Learning objectives are clearly stated and reinforced as students move through the course content, and expectations are reflected concisely in my syllabi. I employ heavy use of self-reflection/analysis exercises which promote student self-awareness, responsibility and discovery.

Not only do my students engage in self-analysis, but I do as well. I use a

Clinical Educator Self-Evaluation Tool (Reuler, Gavett, McCready, & Raleigh [2011]) to evaluate my clinical instructional strategies. I have included an example in my evidence documentation.
