Appointment of Counsel

The Texas Indigent Defense Commission (TIDC) will share proper procedures and best practices for ensuring the appointment of counsel to defendants alleged of crimes in Texas happens in a timely, lawful manner.

Civil Scenarios: Pre-judgment Procedure

The 88th Legislature changed the way juvenile criminal cases will be handled, beginning in January 2025. This class will run through all the details of juvenile diversions, including options for courts and how to fund staff to assist in solving these difficult challenges that lead juveniles into our court system.

Indigence & Financial Literacy

Judicial Leadership

Do you work as a team in your county? Learn how building relationships and sharpening your leadership skills can make your job as a judge easier and more effective.

Magistrating Out-of-County Warrants

Out-of-county warrants pose some unique challenges, which will covered in this class. Topics will include determining if you have jurisdiction to make a bail decision, understanding problems that arise if procedures aren't followed, and dealing with out-of-state warrants.

Mental Health Resources for Judges

TLAP helps judges with issues related to substance use or mental health disorders and maintains a list of volunteer judges who are interested in providing support to peers in crisis. This class will feature a discussion with TLAP and the resources available for judges dealing with issues such as vicarious trauma.

ODL Update: Application & Orders

This course will go over the changes to the ODL laws passed in the 2023 legislative session and will include scenarios and discussion.

Ordering and Understanding Toxicology Reports

This course will help justices of the peace gain a base knowledge for when toxicology testing is appropriate, how to interpret toxicology results, and why they might want to discuss them with medical examiners and toxicologists during inquest investigations.

Panel Discussion: Working Within Your County - 2 civil hrs

This course will explore the justice of the peace's role in the county from the perspectives of other county officials. Judges will have the opportunity to discuss common issues, concerns, and best practices for working together respectfully in a county environment.

Personal Injury with Gwyneth Paltrow - Civil Jury Trial

Did you ever want a movie star to help you brush up on civil jury trials? This class will provide that by going through clips from Gwyneth Paltrow's personal injury case to learn how to properly adjudicate these types of cases in justice court.

Procedural Fairness: Equal Access to Justice

It is crucial for courts to ensure that all parties have equal access to justice. During this course, attendees will discuss how judges can make sure that their courts are welcoming and that their processes are fair and transparent for all parties.

Reducing DWI: The Magistrate's Role

Magistrates can have a direct impact on the safety of Texas roadways. This class will review the current Texas impaired driving trends and the proper procedures for magistrating these cases, including determining probable cause and issuing the proper bond conditions.

Rural Magistration & EDO Issues

Join your fellow judges for a discussion regarding issues that arise in rural counties when magistrating at the jail and issuing Emergency Detention Orders. Topics will include transportation, resources, and services in rural areas.

Trauma-Informed Courts

Many people who work or appear in a court environment have experienced traumatic experiences or profound grief and loss. These types of difficult experiences can affect a person's physical health, mental health, and ability to be productive at work. Work environments which ignore the role that trauma and grief can play in the lives of employees and those who come to court are at risk for reduction in productivity and performance and intense interactions. Becoming trauma-informed can help improve professional connections, increase safety, and maintain valuable employees. This presentation will teach you how to use compassion and empathy to engage with those suffering from trauma or profound grief or loss. Through empathic understanding, we can create an environment where we can connect with coworkers, clients and customers and, when necessary, help de-escalate situations where trauma survivors may be showing signs of feeling emotionally overwhelmed or triggered.

Truancy Scenarios

Join a judge and clerk who handle many truancy cases in an interactive discussion using real-world scenarios to get to the best practices in handling truancy cases in justice court.

Unusual Eviction Scenarios

Evictions can be some of the trickiest cases justice courts encounter. This class will address some of the unusual eviction issues through scenarios on topics including marriage/community property in evictions, squatter's rights, and other unusual landlord/tenant relationships.

What Happens With My Writ?: Role of the Constable
