Subject: Student Government Senate Bill Legislation 2020-2021.5

Legislation and the Student Body President's cover memo for S.B.2020-2021.05 "Excused Absences and Tardies for Chronic Illness or Disability Act," which was passed by the Student Government Senate on November 16th, 2020, is attached:

While I support Student Government being a self-regulating body that can make its own rules and procedures, I do not agree with the procedure set forth in this legislation. The procedure requires Senators who ask for an excused absence due to a disability to provide a note from a doctor or the Office of Disability Services to be submitted to the Senate Chair. This may requires the student to disclose the nature of their disability to another student in order to receive an excused absence. The Senator who researched the legislation was advised against this approach by me and by the Director of the Office of Disability Services. I appreciate the Senate's attempt to be inclusive for Senators with disabilities, but I believe there is a better procedure that achieves being more inclusive and does not infringe on a student's privacy. A more inclusive approach may be for Student Government Student Senate to revise their Absence Policy to replace the types of absences and requirement of documentation with a total number of absences for each Senator.

Please note Senate Bills, like this one, are under the Dean of Students purview for response.

Legislation Passed: S.B.2020-2021.5 Senate Bill Entitled Excused Absences and Tardies for Chronic Illness or Disability Act

Number of Vote: 29 voted in favor, 0 voted in opposition, 0 voted to abstain

I approve this legislation passed by the Student Government Senate entitled Excused Absences and Tardies for Chronic Illness or Disability Act that calls for the University to add up to 4 excused absences for documented Chronic Illness or Documented Disability.

A Bill

To be entitled "Excused Absences and Tardies for Chronic Illness or Disability Act," which adds up to 4 absences for documented Chronic Illness or Documented Disability.

- **WHEREAS:** The Senate should strive to be accommodating to all students and to accommodate their specific situations; and
- **WHEREAS:** While it may be desirable to punish senators for absence, accommodation should be made for those with documented chronic illness or disability; and
- **WHEREAS:** The Senate Standing Rules and Regulations do not currently specifically provide for absences for chronic illness or disability, therefore,
- **BE IT ENACTED:** That the Senate Standing Rules and Regulations be amended in Article VII, Section 5 by inserting a new section (f) and rolling down existing paragraph (f) into a new paragraph (g):
 - (f) Four (4) excused absences related to a Doctor documented or University Office of Disability Service documented chronic illness or disability. An absence related chronic illness or disability that causes an absence must be supported by a Doctor's note or documentation from the Office of Disability Services and must be provided the Chairperson within 72 hours after the chronic illness or disability related absence; and

- **BE IT ENACTED:** That the Senate Standing Rules and Regulations be amended in Article VII, Section 6 by inserting a new section (f) and rolling down existing paragraph (f) into a new paragraph (g):
 - (f) Four (4) excused tardies related to a Doctor documented or University Office of Disability Service documented chronic illness or disability. A tardy related chronic illness or disability that causes a tardy must be supported by a Doctor's note or documentation from the Office of Disability Services and must be provided the Chairperson within 72 hours after the chronic illness or disability related tardy; and
- **BE IT ENACTED:** That upon passage this Bill be forwarded to the Student Body President for further action.
