Subject: Student Government Senate Resolution Legislation 2020-2021

Nineteen pieces of passed 2020-2021 Senate Resolutions from Student Government are attached and listed below.

**S.R.2020-2021.01 Resolution to Accept and Implement TXST Covid-19 List of Demands**

This legislation intends to support several demands of protestors from the Texas State University administration, which include providing additional paid sick leave; hazard pay; full refunds for tuition and fees; compensation of university and private contractors' hourly and salary employees who were laid off due to COVID-19; suspension of Wells Fargo student loan payments by Wells Fargo; Chartwells payment of sick leave to Chartwells, and rent and evictions freeze by A.C.T. housing affiliates.

**S.R.2020-2021.02 Resolution Calling for the University to Adopt Cite and Release Policies**

This legislation intends to recommend the University to adopt cite and release policing policies like those adopted by the City of San Marcos in April 2020.

**S.R.2020-2021.03 Resolution Calling for Reduced Student Fees for Fall 2020**

This legislation intends to recommend the University implement a reduced student fee schedule to not include or lessen fee costs for things students would not be able to use such as for athletics, LBJSC (e.g. SACA events), recreation (e.g. Student Recreation Center), and transportation (e.g. buses).

**S.R.2020-2021.04 Resolution Calling for Budget Transparency**

This legislation intends to recommend the President of Texas State University, or her designee must introduce the proposed budget in a manner that provides at least 14 days' time for the Assembly (i.e., Student Senate and Graduate House) to review

**S.R.2020-2021.05 Resolution in Support of the Reduced Student Fees in Fall 2020 and Calls for Extension of Reductions in Spring 2020**

This legislation intends to support the change in fee structure announced by the university for the Fall 2020 outbreak and should the university convert to a fully online academic experience in Fall 2020 or Spring 2021, and reduce access to university resources, Texas State University must develop a reduced student fee schedule for the Athletics Fee, Student Center Fee, Student Recreation Center, Transportation Services Fee, and Student Service Fee based on the level of programs and/or services each funding source will be able to provide to the student body (e.g., student's ability to attend athletic events, reductions to SACA's programming schedule, inability to reserve space in LBJ, inability to use workout facilities, reduced shuttle services, etc.).

**S.R.2020-2021.06 Resolution in Support of Adopting 8 Can't Wait Policing Policies**

This legislation intends to call for the University Police Department to adopt and enforce the policies articulated by the 8cantwait campaign and have the policies available on their website. (8cantwait.org)

**S.R.2020-2021.09 Resolution Calling for Non-Policing Alternatives for Campus Safety**

This legislation intends to call for alternative methods for ensuring campus safety and ending the over-policing of Texas State University.

**S.R.2020-2021.10 Resolution in Support for The Texas State Employees Union's Petition**

This legislation intends to call for Texas State to accept the demands of the TSEU (CWA Local 6186) in full to ensure that Texas State adequately

**S.R.2020-2021.11 Resolution Calling for The Texas State University President to Formally Request That the San Marcos District Attorney Drop All Charges Placed Against the Student Protestors Arrested in May 2018 and 2019**

This legislation calls for University President Trauth, and all other relevant University administrators, to make a public and formal request for the San Marcos District Attorney to drop all outstanding charges placed against the students and release a public apology for the actions of the University in those instances, in an effort allow healing to take place on campus.

**S.R.2020-2021.12 Resolution Calling for the Establishment of a Cultural Activities Fee**

This legislation intends to recommend that the University implement a \$5.00 Cultural Activity fee for students enrolled for courses at the San Marcos campus and that students may attend productions and events relating to the fine arts free of charge, and the fee will be overseen by a committee of students and faculty.

**S.R.2020-2021.13 Resolution Calling for the Theatre Department to Adjust its Curriculum to Better Accommodate Students**

This legislation intends to call for the Theatre Department to adjust courses TH4390 through TH4393 to be less strenuous for students.

**S.R.2020-2021.14 Resolution Calling for the Expansion of Mental Health Resources**

This legislation calls on the university to adopt outreach for mental health assessments, the adoption of Biofeedback rooms, and more effort towards outreaching for funding for mental health from different sources across the country.

**S.R.2020-2021.15 Resolution calling for Stopping Coronavirus Spread by Increasing Testing Capability**

This legislation intends for Student Government to urge campus administration and the Student Health Center to speed up testing in an effort to deliver results within at most 2 days due to its time-sensitive importance.

**S.R.2020-2021.16 Resolution Calling for the Installation of Artistic Murals**

This legislation intends to recommend the university to commission more artistic works on campus and to commission students to do the artwork.

**S.R.2020-2021.17 Resolution Calling for Updated Calorie and Diet Specific Information in Dining Halls**

This legislation intends to recommend Chartwells provides more updated dietary information to be posted in dining halls.

**S.R.2020-2021.18 Resolution Calling for the Creation of Cultural Diversity Flagged Course in Required Curriculum**

This legislation intends to recommend the University to flag specific types of cultural diversity courses in the student enrollment system and require two flagged courses for graduation.

**S.R.2020-2021.19 Resolution to Leverage Bobcat Trace to Further Mental Health Outreach from the University**

This legislation intends to recommend the University reformat Bobcat Trace to be used as a way for students to assess their mental health state, and potentially get on track to receiving aid streamlining the scheduling process.

**S.R.2020-2021.20 Resolution Calling on Free Masks in Major Student Service Buildings**

This legislation intends to recommend free masks at entrances of student services buildings such as Alkek, LBJSC, and the Student Recreation Center.

**S.R.2020-2021.21 Resolution to Encourage Fee Transparency When Registering for Classes, Through an Online Code Pledge**

This legislation intends to have a pledge that will be sent out to professors so they can choose to sign it or not, in an effort to be more transparent about course fees.

Subject: Student Government Passed Legislation: Senate Resolutions

With the intention of honoring the senate's role as a representative body, no resolution passed by the senate during the year 2020 was vetoed. However, I hold my strongest reservations about two particular pieces. I request that my reservations be attached to these selected pieces.

Legislation Passed: S.R.2020-2021.11 Resolution Calling for The Texas State University President to Formally Request That the San Marcos District Attorney Drop All Charges Placed Against the Student Protestors Arrested in May 2018 and 2019

Number of Vote: 19 voted in favor, 11 voted in opposition, 0 voted to abstain

**Acceptance of this legislation by the TXST Administration would be a direct incentivization of unlawful action and disobedience by students. Secondly, the content of this legislation was misrepresented before the senate by its author and sponsors during consideration.**

Legislation Passed: S.R.2020-2021.12 Resolution Calling for the Establishment of a Cultural Activities Fee

Number of Vote: 26 voted in favor, 4 voted in opposition, 0 voted to abstain

**This legislation recommends the introduction of a universal fee for a service already available to students at "a highly reduced cost", in the words of the piece. At this time, the greater student population is wholly uninterested in increasing the cost of attendance for this purpose.**

**A Resolution**

**To be known as "A Resolution to Encourage Fee Transparency When Registering for Classes Through an Online Code Pledge."**

**WHEREAS:** The Student Government of Texas State University, on behalf of the student body of Texas State University, would like to address; and

**WHEREAS:** Professors often don't inform their students of online fees that they will have to pay to take the class, until class has already started; and

**WHEREAS:** Professors sometimes wait until the very last minute to create a Canvas site and syllabus, so students are not able to see what they will be paying for until after class has started; and

**WHEREAS:** Students feel that they are making a blind commitment and are almost forced to make these purchases in order to take the class when they are already paying for the class as a whole; and

**WHEREAS:** The Academic Affairs Committee has created an Online Code Pledge; therefore,

**BE IT RESOLVED:** That the pledge will be sent out to professors so they

can choose to sign it or not. The Online Code Pledge reads:

"I, \_\_\_\_\_, join Texas State University Student Government in their efforts to reduce the use of online learning codes that require purchase. In signing this, I am not forbidden from using online textbooks. Rather, this means that as a Texas State University faculty member, I will strive to reduce the purchases of both a textbook and an online code.

I will do so by:

Being up front before my class starts, sending out a notice, and ensuring my students know exactly what they're paying for in order to reduce "hidden fees" that may arise when class starts. This includes not requiring my students to purchase an online learning system, or a code, in addition to the textbook purchase.

Further,

By signing this pledge, I grant Texas State University Student Government permission to make this information public.
