## A Resolution

To be known as "A Resolution Reducing the Prices of Food And Beverages" relating to requesting Chartwells to overhaul the concession menu at Texas State University athletic events.

WHEREAS: The Student Government of Texas State University, on behalf of the student body of Texas State University, would like to address the high concession pricing at athletic events; and

WHEREAS: Current concession stand pricing at Texas State athletic events is costly for students and fans as a result affecting the fan experience and attendance; and

WHEREAS: Several schools have connected the issue between high costs to attend games and low attendance, as a result overhaling concession menu; and

WHEREAS: The University of Louisiana Lafayette a member of the Sunbelt Conference created "Fan-Friendly" concession pricing which includes bottled water, hamburgers, cheeseburgers, pretzels, nachos, fountain soda, 16 oz domestic beer cans, and Frito chili pies. All items are available for $\$ 3$ or less under their new pricing structure implemented in 2019; and

WHEREAS: Overhauling the concession menu by reducing prices would help the University's ongoing problem of low attendance at athletic events; therefore,

BE IT RESOLVED: That the student body requests Chartwells to overhaul the concession menu to reflect that of University of Louisiana Lafayette to increase fan experiences and attendance; and

BE IT FURTHER RESOLVED: This legislation be forwarded to the Student Body President for further action.
