1 **A Resolution**

2 To be known as "The Excellence in Greek Life Award Resolution,"  
3 which implements an award highlighting a Greek student  
4 organization that exemplifies Texas State Values.

5 **WHEREAS:** Student Involvement, creative activities,  
6 cultivation of honorable and ethical students, a  
7 diversity of people and ideas, and a commitment  
8 to service and leadership are the premier values  
9 of Texas State University; and

10 **WHEREAS:** Stating that inherently the values of Texas State  
11 University are the values of Student Government  
12 and leads Student Government to have a  
13 responsibility to carry these out; and

14 **WHEREAS:** Encouraging students to join student  
15 organizations leads to a fulfillment of the  
16 "college experience;" therefore,

17 **BE IT RESOLVED:** That the creation of the Excellence in Greek  
18 Life Award be actualized to highlight a genre of  
19 student organizations that exemplifies Texas  
20 State Values; and

21 **BE IT FURTHER RESOLVED:** The Excellence in Greek Life Award  
22 primarily be awarded to Delta Sigma Phi, a  
23 staunch example of these values; and

24 **BE IT FURTHER RESOLVED:** The Texas State Student Government  
25 Award this "Excellence in Greek Life Award" bi-  
26 annually to the Greek Student Organization  
27 chapter on campus deemed most deserving by a  
28 majority vote in the Senate.
