- Major employers: manufacturing, distribution, healthcare, government




- 214 civil service sworn positions



Fatality Crashes in Denton





Why DWI Enforcement?

- In 2019, in the US, **10,196** people were killed in motor vehicle alcoholimpaired crashes (BAC .08 or greater)
 - 1,338 in Texas led the nation
- In 2020, the number was 11,718
 - 1,533 in Texas led the nation
- In 2021, the number was 13, 384
 - 1,906 in Texas led the nation
- 2003-2018 total in-theater deaths related to Iraq & Afghanistan wars ~
 7,200




Denton Impairment & Crashes


• CRIS Query of all crashes involving a driver under the influence of alcohol or a drug (BAC over 0.01 or positive for drugs, medications)




- Statewide in 2023, over 630,000 reported crashes; just under 28,000 of them were under the influence of alcohol or drug, roughly **4.3**% of all crashes had an impairment level
- Denton in 2023, over 3,100 reported crashes, just under 200 of them were under the influence of alcohol or drug, roughly **6.2**% of all crashes had an impairment level









Phone calls...

- Denton should produce 300+ blood warrants per year
- Not evenly distributed
- Centered around holidays
- Warrants can vary by month (22% 40%)
- Your milage may very (Population, culture, arrestees)

CCP 724.017 Taking of Blood Specimen

- (a) Only the following may take a blood specimen at the request or order of a peace officer under this chapter:
 - A physician
 - A qualified technician
 - A registered professional nurse
 - A license vocational nurse
 - A license or certified EMT-Intermediate or EMT-paramedic
- (a-1) The blood specimen must be taken in a sanitary place.

Who can draw blood

- A phlebotomist is considered a qualified technician:
 - Brown v. State, No. 12-15-00205-CR, 2016 WL 4538609
 - State v. Bingham, 921 S.W.2d 494
- But qualifications must be proven:
 - Torres v. State, 109 S.W.3d 602

Sanitary place

- State v. Johnston 336 S.W.3d 64
 - Upheld blood draw in jail. Found EMT was not qualified technician (statue updated shortly after case was decided)
- Battles v. State, No. 05-13-00106-CR, 2014 WL 5475394
 - Sanitary placed focused on specific area where blood was drawn (arm/chair). Upheld blood draw in jail intoxilyzer room.

Sanitary place

- Zalman v. State, No. 13-13-00471-CR, 2015 WL 512914
 - "While we agree that an environment totally devoid of insects would be an ideal environment in which to draw blood, *Schmerber* does not require an ideal environment, only a safe one"

No Refusal

If your agency is going to put in the work to stand up and administer an in-house phlebotomy program, you need to be a 24/7/365 no-refusal agency.

Remember...

- Although obtaining a specimen is the ultimate goal, a good DWI investigation should not solely rest on the breath test report or lab report
- You can make your case long before that point with a solid investigation during the vehicle in motion and personal contact phases.
- The lab report should just be a bonus in most cases

Pros: No charge • No charge • 24/7 availability Cons: • No control over the process in terms of service (we were not a priority for them) • Safety concerns • Transport/waiting times; search warrant vs consent

Where do you start?

- Does your jurisdiction have a big enough DWI problem?
 - Problem isn't just defined by the number of arrests
- Do you have a facility where blood draws can be completed?
 - TRC Ch 724.017 defines blood draw statutory procedures
 - Minimum of a qualified technician & sanitary place
 - Get your District Attorney / Prosecuting Attorney on board with idea
- · How are you going to pay for it?
 - City / County budget

Where do you start?

- Who is going to perform the draws?
 - · Talk to your city/county Risk Management section first
 - FD, Officers, Jail staff, 3rd party (contracted technicians, hospital staff, etc.)
- Blood draw options
 - Hospital/clinic
 - County jail (medical staff)
 - Local jail
- Write SOPs
- Get media coverage!

What do you need?

- Secure and sanitary area
- Phlebotomy chair
- Phlebotomy cart or storage cabinet
- Cleaning supplies
- DPS blood vial kit

- Blood draw supplies
 - Medical gloves
 - Tourniquet
 - BZK wipe or non-alcohol-based cleaning wipe
 - Vacutainer with tubing
 - Gauze
 - Bandage
 - Medical tape
- Qualified technician

Financial Savings – back of the envelope

- A very conservative savings:
 - \$22,900 in 2023
 - \$33,200 in 2024
- But wait, there's more...

Other savings/factors

- Increased safety for officers and arrestees
- Multi-officer responses are common
- Increased synergy
- Faster blood draws mean better blood draws
- Agency controls process
- Cultural impact

The green wave



- Cannabis legalization has nationally caused:
 - A 6.5% increase in injury crashes
 - A 2.3% increase in fatal crashes
- In Colorado, from 2013 2018:
 - A 151% increase in cannabis traffic fatalities
 - A 35% increase in all fatalities
 - In 2017, 21.3% of all fatalities were related to cannabis.
