**SECTION 1 – GENERAL INFORMATION & REQUIREMENTS**

- 1.1 **GENERAL INFORMATION:** The Texas State University System (“TSUS”, or “Owner”) on behalf of **Sul Ross State University and itself**, is soliciting Statements of Qualifications (“Qualifications”) for the selection of a firm or firms to provide **Indefinite Quantity-Indefinite Delivery (“IDIQ”) Architectural/ Engineering (“A/E”)** services for planning, design, renovation and new construction of projects for Sul Ross State University (“Member”) in Alpine, Del Rio, Eagle Pass, and Uvalde, Texas; and, TSUS property in Terlingua, Texas, on an hourly fee or lump sum basis as needed by the Member or TSUS. Expected required services include, but are not limited to, pre-project planning, cost estimating, programming, design, construction document preparation, bidding assistance, and construction phase administration, or any other professional A/E services that are beneficial in the delivery of facilities. The A/E will render these services to the Member or TSUS as needed, with no minimum or maximum amount of services specified. In particular, the A/E must be prepared to assign at least one person with significant project planning and management experience to be available as the point of contact for all efforts at the Member institution or TSUS. An agreement with the selected firm(s) will be issued as an indefinite quantity indefinite delivery Professional Services Agreement with a **three (3) year initial term and an option for the Owner to extend the contract for two (2) additional one (1) year terms. The total value of the Contract term shall not exceed Three Million Dollars (\$3,000,000) for the total life of the agreement.** However, the Owner reserves the right to increase this monetary limit. This solicitation sets forth the terms, conditions, and requirements for prospective A/Es to be considered for this work. (Prospective A/Es are hereinafter referred to as “Respondents”).
- 1.1.1 Collecting Qualifications in response to this Request for Qualifications (“RFQ”) is the first step in selecting the A/E(s). This RFQ provides the information necessary for Respondents to prepare and submit Qualifications for consideration and initial ranking by the Member. In the next step the Owner will determine an initial ranking of the Respondents. If the initial ranking of the Respondents is reasonably conclusive, the Owner may make a “most qualified” selection based upon the written Qualifications only. If not, then the Member in conjunction with the Owner may conduct interviews with a “short list” of Respondents.
- 1.1.2 The Owner may select up to four (4) of the top ranked qualified Respondents to participate in an interview with the Member and Owner to confirm and clarify the Qualifications submitted and to answer additional questions. The Owner will then rank the interviewed Respondents in order to determine the most qualified Respondent(s).
- 1.1.3 After selecting the most qualified Respondent(s) the Owner will negotiate the services to be provided by the A/E and a suitable fee schedule for those services.
- 1.2 **PUBLIC INFORMATION:** All information, documentation, and other materials submitted in response to this solicitation are considered non-confidential and/or non-proprietary and are subject

to public disclosure under the Texas Public Information Act (*Texas Government Code*, Chapter 552.001, *et seq.*) after the solicitation is completed. The Owner complies with all statutes, court decisions, and opinions of the Texas Attorney General with respect to disclosure of RFQ information. Additionally, pursuant to the provisions of *Texas Government Code* Section 2261.253, the contract resulting from this solicitation will be posted on the Owner's website.

1.3 **TYPE OF AGREEMENT:** Any agreement resulting from this solicitation will be in the form of the Owner's Standard Indefinite Delivery Indefinite Quantity Professional Services Agreement for A/Es a copy of is posted with the RFQ on the Electronic Business Daily (ESBD) website at: <https://www.txsmartbuy.com/esbd> The Agreement should be viewed as a draft and is subject to change.

1.4 **CLARIFICATIONS AND INTERPRETATIONS:** Discrepancies, omissions or doubts as to the meaning of RFQ documents shall be communicated in writing to the Owner for interpretation. Any responses to inquiries, clarifications, or interpretations of this RFQ that materially affect or change its requirements will be posted by the Owner as a written addendum. All such addenda issued by the Owner before the proposals are due become part of the RFQ. Respondents shall acknowledge receipt of and incorporate each addendum in its Qualifications. Respondents shall be required to consider only those clarifications and interpretations that the Owner issues by addenda. Interpretations or clarifications in any other form, including oral statements, will not be binding on the Owner, and should not be relied on in preparing Qualifications. It is the responsibility of all Respondents to check the status of formal addenda seven (7) calendar days before the submittal deadline. The deadline for the receipt of written questions and submittal deadline is stated in Section 2.4.

1.5 **SUBMISSION OF QUALIFICATIONS:**

1.5.1 The Qualifications must be received **at the address specified in Section 1.5.2 prior to the date and time deadline.** Please note that overnight deliveries, such as FedEx and UPS, arrive at a central campus location but are not usually delivered to the specified location until after the time deadline. Respondents are advised to use other methods of delivery or, if using an overnight delivery service, to send the Qualifications a day earlier than usual. The Owner will not consider any response to this solicitation that is not received at the address specified by the deadline, regardless of whether it has been received by the University.

- 1.5.3 Submit five (5) identical hard copies of the Qualifications and two (2) digital copies on USB/flash drives in Adobe Acrobat PDF format. An original signature must be included on the Respondent's "Execution of Offer" document submitted with each hard copy.
  - 1.5.4 Submit two (2) identical hard copies of the HUB Subcontracting Plan ("HSP") and two (2) digital copies on USB/flash drives in Adobe Acrobat PDF format, as a separate attachment from the Qualifications, as described in Section 1.13.
  - 1.5.5 Qualifications received after the deadline in 1.5.2 will be returned to the Respondent unopened. The individual identified in Section 1.5.2 will identify the official time clock at the RFQ submittal location identified above.
  - 1.5.6 The Owner will not acknowledge or consider Qualifications that are delivered by telephone, facsimile (fax), or electronic mail (e-mail).
  - 1.5.7 Properly submitted Qualifications will not be returned to Respondents.
  - 1.5.8 Respondent's Qualifications and HSP materials must be enclosed in a sealed envelope (box or container) addressed to the Point-of-Contact person. Packages must clearly identify the submittal deadline, the RFQ title and number, and include the name, return address, and email address of the Respondent's contact person on all envelopes. The HSP (electronic and hard copies) shall be included with the Qualifications (electronic and hard copies) packet but sealed separately.
  - 1.5.9 Properly submitted Qualifications will be opened publicly and the names of the Respondents will be read aloud immediately after the submissions of Qualifications deadline stated in Section 1.5.2.
- 1.6 **POINT-OF-CONTACT:** The Owner designates the following person as its representative and Point-of-Contact for this RFQ. Respondents shall restrict all contact with the Owner and direct all questions regarding this RFQ, including questions regarding terms and conditions, in writing to the Point-of-Contact person **by via email only.**

- 1.7 **EVALUATION OF QUALIFICATIONS:** The evaluation of the Qualifications shall be based on the requirements described in this RFQ. All properly submitted Qualifications will be reviewed, evaluated, and ranked by a Selection Committee appointed by the President of Sul Ross State University or their designee. Typically, that committee will include facilities professionals, as well as representation from The Texas State University System. The top four (4) or fewer ranked Respondents may be selected by the Owner for further consideration by participating in an interview wherein Qualifications will be presented and examined in further detail and where questions will be posed by the Selection Committee and answered by the Respondent.
- 1.7.1 Qualifications submittals shall not include any information regarding Respondent's proposed fees, pricing, or other compensation considerations as these will not be a factor in the selection of the most qualified Respondent(s).

- 1.8 OWNER'S RESERVATION OF RIGHTS: The Owner reserves the right to reject any and all Qualifications and re-solicit for new Qualifications, or to reject any and all submissions and temporarily or permanently abandon the solicitation. Owner makes no representations, written or oral, that it will enter into any form of agreement with any Respondent to this RFQ for any project and no such representation is intended or should be construed by the issuance of this RFQ.
- 1.9 ACCEPTANCE OF EVALUATION METHODOLOGY: By submitting its Qualifications in response to this RFQ, Respondent accepts the evaluation process and acknowledges and accepts that determination of the "most qualified" Respondent(s) will require subjective judgments by the Owner. Determinations by the Selection Committee will be subject to routine administrative review by the Owner's executive officers but, once a selection is announced, it will not be subject to further review.
- 1.10 NO REIMBURSEMENT FOR COSTS: Respondent acknowledges and accepts that any costs incurred from the Respondent's participation in this RFQ process shall be at the sole risk and responsibility of the Respondent.
- 1.11 PRE-SUBMITTAL CONFERENCE: There will be no pre-submittal conference conducted for this selection process.
- 1.12 ELIGIBLE RESPONDENTS: Only individual firms or lawfully formed business organizations may apply (This does not preclude a Respondent from using consultants.) The Owner will contract only with the individual firm or formal organization that submits a Qualification.
- 1.13 HISTORICALLY UNDERUTILIZED BUSINESSES' SUBMITTAL REQUIREMENTS: It is the policy of the Owner and each of its Member institutions, to promote and encourage contracting and subcontracting opportunities for Historically Underutilized Businesses ("HUB" or "HUBs") in all contracts. Accordingly, specific plans and representations by Respondents that appear to facilitate the State's commitment to supporting HUB enterprises are required in the selection process. Failure to submit specific plans and representations regarding HUB utilization, or failure to address the subject at all, will be interpreted by the Selection Committee as an intention to not support the program and will disqualify the Respondent. A HUB Subcontracting Plan (HSP) is required as a part of the Respondent's Qualifications.
- 1.13.1 The HSP information may be downloaded from the Texas State Comptroller's website at the following URL link: <https://comptroller.texas.gov/purchasing/vendor/hub/forms.php>
- 1.14 CERTAIN PROPOSALS AND CONTRACTS PROHIBITED: Under Section 2155.004, *Texas Government Code*, a state agency may not accept a proposal or award a contract that includes proposed financial participation by a person who received compensation from the agency to participate in preparing the specifications or request for proposals on which the proposal or contract is based. All vendors must certify their eligibility by acknowledging the following statement, "Under Section 2155.004, Texas Government Code, the vendor certifies that the individual or business entity named in this bid or contract is not ineligible to receive the specified contract and acknowledges that this contract may be terminated and payment withheld if this certification is inaccurate." If a state agency determines that an individual or business entity holding a state contract was ineligible to have the contract accepted or awarded as described above, the state agency may immediately terminate the contract without further obligation to the vendor. This section does not create a cause of action to contest a proposal or award of a state contract.
- 1.15 SALES AND USE TAXES: Section 151.311, *Texas Tax Code*, permits the purchase free of state sales and use taxes of tangible personal property to be incorporated into realty in the performance of a contract for an improvement to realty for certain exempt entities that include the Owner. The

section further permits the purchase tax-free of tangible personal property (other than machinery or equipment and its accessories and repair and replacement parts) for use in the performance of such a contract if the property is "necessary and essential for the performance of the contract" and "completely consumed at the job site." In addition, the section permits the purchase tax-free of a tangible service for use in the performance of such a contract if the service is performed at the job site and if "the contract expressly requires the specific service to be provided or purchased by the person performing the contract" or "the service is integral to the performance of the contract."

- 1.16 CERTIFICATION OF FRANCHISE TAX STATUS: Respondents are advised that the successful Respondent will be required to submit certification of franchise tax status as required by State Law (*Texas Tax Code* Chapter 171). The contractor agrees that each subcontractor and supplier under contract will also provide a certification of franchise tax status.
- 1.17 DELINQUENCY IN PAYING CHILD SUPPORT: Under Section 231.006, *Texas Family Code*, the vendor or applicant certifies that the individual or business entity named in this contract, bid, or application is not ineligible to receive the specified grant, loan, or payment and acknowledges that this contract may be terminated, and payment may be withheld if this certification is inaccurate.
- 1.18 STATE REGISTRATION OF ARCHITECTURE FIRMS: Respondents are advised that the Texas Board of Architectural Examiners requires that any firm or business entity (including architects, landscape architects and interior designers) providing architectural, landscape architecture or interior design services to the public, must register with the Texas Board of Architectural Examiners. An entity is defined as a sole proprietorship, firm, partnership, corporation, or joint stock association. The Texas Board of Architectural Examiners, 505 East Huntland Drive, Suite 350, Austin, Texas 78752, telephone (512) 305-9000, has jurisdiction over individuals licensed under the Architects' Registration Law, Chapter 1051, *Texas Occupations Code*.
- 1.19 STATE REGISTRATION OF ENGINEERING FIRMS: Respondents are advised that the Texas Board of Professional Engineers requires that any entity providing engineering services to the public must register with the Texas Board of Professional Engineers. An entity is defined as a sole proprietorship, firm, partnership, corporation, or joint stock association.
- 1.20 NON-DISCRIMINATION: In their execution of this agreement, Respondent, consultants, their respective employees, and others acting by or through them shall comply with all federal and state policies and laws prohibiting discrimination, harassment, and sexual misconduct. Any breach of this covenant may result in termination of this agreement.
- 1.21 NON-BOYCOTT ISRAEL VERIFICATION: Pursuant to Section 2270.002 of the *Texas Government Code*, Respondent certifies that either (i) it meets an exemption criteria under Section 2270.002; or (ii) it does not boycott Israel and will not boycott Israel during the term of the contract resulting from this solicitation. Respondent shall state any facts that make it exempt from the boycott certification in its Response.
- 1.22 CYBERSECURITY TRAINING PROGRAM: Pursuant to Section 2054.5192, *Texas Government Code*, A/E and its consultants, officers, and employees who are provided credentials granting access to Member's computer system also known as Member's information system, must complete a cybersecurity training program certified under Section 2054.519, *Texas Government Code* as selected by the Member. The cybersecurity training program must be completed during the term and any renewal period of this Agreement. A/E shall verify in writing completion of the program to the Member within the first thirty (30) calendar days of the term and any renewal period of this Agreement. Failure to comply with the requirements of this section are grounds for termination for cause of the Agreement.

- 1.23 CERTIFICATION REGARDING BUSINESS WITH CERTAIN COUNTRIES AND ORGANIZATIONS: Pursuant to Subchapter F, Chapter 2252.152, Texas Government Code, Respondent hereby certifies it is not engaged in business with Iran, Sudan, or a foreign terrorist organization. Respondent acknowledges this Agreement may be terminated and payment withheld if this certification is inaccurate.
- 1.24 NON-DISCRIMINATION OF FIREARM INDUSTRY VERIFICATION: Pursuant to Chapter 2274, *Texas Government Code* (as enacted in SB 19 in the 87<sup>th</sup> Regular Legislative Session [2021]), Respondent hereby verifies that either (i) it has less than ten (10) full time employees; or (ii), it does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association (as defined under Section 2274.001, Texas Government Code) and will not discriminate during the term of this Agreement against a firearm entity or firearm trade association.
- 1.25 ANTI-BOYCOTT ENERGY COMPANIES VERIFICATION: Pursuant to Chapter 2276, *Texas Government Code*, Respondent hereby certifies that either (i) it has less than ten (10) full time employees or (ii) it does not “boycott energy companies” (as defined under Section 809.001, *Texas Government Code*) and will not “boycott energy companies” during the term of the Agreement.
- 1.26 VACCINE PASSPORT PROHIBITION: Pursuant to Section 161.0085, Texas Health and Safety Code (as enacted in SB 968 in the 87<sup>th</sup> Regular Legislative Session [2021]), Respondent hereby certifies that it does not require its customers to provide any documentation certifying the customer’s COVID-19 vaccination or post-transmission recovery on entry to, to gain access to, or to receive service from Respondent’s business. Respondent acknowledges that such a vaccine or recovery requirement would make Respondent ineligible for a state-funded contract and shall be grounds for termination of this Agreement for cause.
- 1.27 CRITICAL INFRASTRUCTURE AFFIRMATION: Pursuant to Section 2274.0102, *Texas Government Code*, Respondent certifies that neither it nor its parent company, nor any affiliate of Respondent or its parent company, is (i) majority owned or controlled by citizens or governmental entities of China, Iran, North Korea, Russia, or any other country designated by the Governor under Section 2274.0103, *Texas Government Code*, or headquartered in any of those countries.

## **SECTION 2 – EXECUTIVE SUMMARY**

- 2.1 HISTORICAL BACKGROUND: SRSU was created by the 35th Legislature in 1917 to serve as a state normal college to train teachers. The school, Sul Ross State Normal College, was named after Lawrence Sullivan Ross, Governor of Texas from 1887 to 1891 and President of Texas A&M College from 1891 to 1898. Construction began in 1919 and on June 14, 1920, under the presidency of Thomas J. Fletcher, operations began in the present Dolph Briscoe Jr. Administration Building. The first enrollment in the summer of 1920 included 77 students, who studied education and liberal arts subjects.

In 1923, the state Legislature changed the name to Sul Ross State Teachers College, and advanced courses leading to baccalaureate degrees were added. The first baccalaureate degree was awarded in the summer of 1925. In 1930, graduate level course work began, and the first master’s degrees were presented in 1933. The school experienced continued growth in enrollment and construction until World War II, when portions of the campus housed a U.S. Navy pilot training program and a Women’s Army Corps Training School.



Enrollment grew to more than 1,000 students in 1960 and to over 2,000 in 1970. Academic programs continued to expand and new fine arts, physical education, science, range animal buildings, and a new library were constructed between 1952 and 1974. In 1969, the Legislature again changed the name of the school to Sul Ross State University (“SRSU”) to reflect its status as a comprehensive state university.

SRSU has become the cultural and educational hub for the remote Big Bend region. The school has enriched the area through scientific research in biology, geology, and range animal science, with emphasis on Chihuahuan Desert studies. Through the University’s Center for Big Bend Study, research and educational activities are conducted in historic, cultural, and economic development for the Trans-Pecos region and adjacent areas in Mexico and New Mexico

- 2.2 MISSION STATEMENT: Sul Ross State University seeks to be a national and international leader in achieving excellence among universities in the areas of education, research, social mobility, service, affordability, and shared governance.

- 2.3 SERVICES DESCRIPTION AND SCOPE: The scope of services is to provide, upon notification of a need by the Member or TSUS, providing a Project Services Proposal, and after contracting through a properly executed Task Order, A/E services including, but not limited to, the following:

- 2.3.1 Preparation of studies, reports, schematic plans, preliminary construction cost estimates, measurements, photographic documentation, and project analysis for facilities on Sul Ross State University campuses in Alpine, Del Rio, Eagle Pass, and Uvalde, Texas and TSUS property in Terlingua, Texas.
- 2.3.2 Recommend options for additions, remodeling, replacement, or new construction including project cost analysis.
- 2.3.3 Design services to include preliminary design, construction drawings and specifications for new construction and renovation projects, including preparation of cost estimates and bidding documents as well as assist in the procurement of construction services.
- 2.3.4 General contract administration including on-site observation during construction.
- 2.3.5 General consulting services for assisting the Owner with project management and program management services.
- 2.3.6 Architectural, structural, mechanical, electrical, plumbing, civil and other subconsultants as may be necessary to the A/E in fulfillment of its assignment.

- 2.3.7 **SUBCONSULTANTS:** Subconsultants providing services under any subsequent agreement shall meet the same requirements and level of experience as required of the Respondent. No subconsultant under the agreement shall relieve the primary Respondent of responsibility for the service. If the Respondent uses a subconsultant for any or all of the work required, the following conditions shall apply under the listed circumstances:
  - 2.3.7.1 Respondents planning to subcontract all or a portion of the work shall identify the proposed subconsultant.
  - 2.3.7.2 The Owner retains the right to verify subconsultant’s background and make determination to approve or reject the use of submitted subconsultants.
  - 2.3.7.3 The Respondent shall be the only contact for the Owner and subconsultant. Respondent shall list a designated point of contact for all Owner and subconsultant inquiries.
- 2.3.8 The Respondent and any subconsultant employed by them must be able to quickly respond to a written request for A/E services from the Member or Owner. **I. GENERAL:**

**A.** Below are Questions that were presented along with Answers to each in relation to this RFQ.

- 1. Question:** Are A/E firms that specialize in services such as building envelope consulting or structural engineering able to submit as a prime firm for this solicitation, or would such firms need to be included as a subconsultant under a prime firm?

**Answer:** The solicitation will be evaluated based on the criteria stated under Section 3 of the RFQ. While we do not restrict what type of Architectural/Engineering (A/E) firms can pursue the RFQ, those acting as a prime that specialize in limited aspects A/E services delivery may not score as well as those who are able to demonstrate their experience providing a full range of services as a prime.

- 2. Question:** Does this RFQ include scope for MEP Commissioning Services, or will this scope come out separately?

**Answer:** This solicitation is for general A/E services on an as needed basis. Depending on a specific need of the university, A/E services could include multiple disciplines including, but not limited to, Civil, Structural, MEP, IT, AV, Security, Landscape, Cost Estimating, and the like. If Commissioning services are required, they may be procured through the A/E or otherwise provided by the university. No separate solicitation for MEP Commissioning services is anticipated.

- 3. Question:** Upon review of the solicitation, we noted that the directions state that the submission is to be delivered to Sam Houston State University (Section 1.5.2). We want to make sure this instruction is correct.

**Answer:** The information contained in 1.5.2 is correct.

- 4. Question:** Confirming that the HUB goal for this IDIQ contract is 23.7% (for professional services). Does the HUB goal need to be met on each potential project, or the IDIQ contract as a whole?

**Answer:** As a goal, Respondents should strive to allocate at least twenty percent (20%) of the proposed services required under this RFQ to qualified consultants, which are Historically Underutilized Businesses (HUB or HUBs). If the A/E is a HUB, it should strive to perform at least twenty-five percent (25%) of the work. The HUB Subcontracting Plan submitted as part of this RFQ should demonstrate the Respondents commitment to supporting HUB enterprises at these levels. At the time of a Task Order award, the A/E shall submit a project specific HUB Subcontracting Plan based on the HUB Subcontracting Plan submitted as part of the RFQ.

**I. GENERAL:**

**A.** Below are Questions that were presented along with Answers to each in relation to this RFQ as of August 13, 2024, 12:00 p.m.

**1.** **Question:** Please confirm that an MEP firm can submit on this contract without an Architect.

**Answer:** The posted RFQ is for conventional Architectural/Engineering services, where an architect is traditionally in the lead. MEP firms can submit their qualifications in response to the RFQ but must include an architectural firm as part of their subconsultant team. As stated in reply to Question Number 1, in Addendum Number 1: “The solicitation will be evaluated based on the criteria stated under Section 3 of the RFQ. While we do not restrict what type of Architectural/Engineering (A/E) firms can pursue the RFQ, those acting as a prime that specialize in limited aspects of A/E services delivery may not score as well as those who are able to demonstrate their experience providing a full range of services as a prime.”

**2.** **Question:** As an MEP firm, certain project requirements (listed in 3.4.1) are not always applicable. Please confirm if we would need to include all information for each project, i.e., planned versus actual durations for Schematic Design, Design Development and ninety five percent (95%) Construction Documents phases; provide an explanatory justification for any slippage of dates exceeding fifteen (15) calendar days between planned and actual dates for each milestone; et al.

**Answer:** Criterion Four is intended to allow for an evaluation of the Respondent’s performance in past representative projects as the Owner attempts to select “...the most highly qualified provider of those services on the basis of demonstrated competence and qualifications.” In conformance with the requirements of TGC Sec. 2254.004. A Respondent’s inability to provide all of the information requested under Criterion 4 will not disqualify the Respondent but could impact how their Qualifications submittal is evaluated.

**3.** **Question:** We plan to submit subconsultants for this project, can you please clarify which sections of the RFQ requirements need to also be completed by the subconsultant? i.e., sections 3.2, 3.5, and 3.6., and which ones are only required by the prime firm.

**Answer:** The prime firm that signs the Execution of Offer is the lead Respondent to the RFQ. The Criterion questions under Section 3 of the RFQ are directed at them and any references to proposed consultants contained in Section 3 are to be presented by the Respondent on behalf of their proposed consultants. There are no portions of the statement of Qualifications that need to be completed by a proposed consultant.

4. **Question:** Section 2.3.3. Design services to include preliminary design, construction drawings and specifications for new construction and renovation projects, including preparation of cost estimates and bidding documents as well as assist in the procurement of construction services. My question is: Are the services above that I have highlighted and underlined required as part of this RFQ?  
**Answer:** The successful Respondent(s) to this RFQ who are awarded an A/E IDIQ Agreement are very likely to be engaged in these types of professional services under a Task Order, if and when such a Task Order is issued.
5. **Question:** Please confirm if two (2) signatures from the Respondent company may be used instead of one (1) on the professional services agreement, in order to observe internal company controls (Reference § 3.6.7)  
**Answer:** If the Respondent is successfully awarded an A/E IDIQ Agreement under this RFQ, a means to incorporate two (2) signatures into the final Agreement can be negotiated.
