If your vendor does NOT appear on the Hold Report, please take a screenshot of where the name would appear if it was on the list. The report is alphabetical when searching with one wild card (Ex: Smith*). Then, use this for your documentation purposes.

If your vendor DOES appear on the Hold Report, please contact the P&SS office so we can further verify. We will need the tax ID number (W9) of the vendor as well as the TINS number (State ID). The TINS can be found on the Hold Report, it is the first column. You will be responsible for receiving the tax ID (W9) from the vendor and provide it to the P&SS office for our purposes of further verification.
