 I will restrict my participation in club activities to coaching and refrain from engaging in any activities affecting club management.
 I have no authority to engage the club or the University in any contracts or agreements without the express written consent of the Assistant Director of Competitive Sports.
 I will communicate with the Assistant Director of Competitive Sports for any and all matters involving my coaching of a club. I will not contact other campus departments without Campus Recreation's prior authorization, except in emergency situations. If such a situation arises, I will inform Campus Recreation as soon as possible.
 I have reviewed and agree to comply with all Sport Clubs, Department of Campus Recreation and Texas State rules and guidelines regarding the administration of a club.
 I will comply with risk management guidelines for the safety of club members, opponents and spectators.
 I will always ensure proper sportsmanship and will notify the Assistant Director of Competitive Sports for assistance in dealing with club members who display unsportsmanlike conduct.
 I will not offer monetary or scholarship awards to any individual as incentives to participate.
 I understand that my participation as a coach to a club does not create an employee/employer relationship between myself and the Department of Campus Recreation or Texas State University.
 I understand that my participation as a coach to a club does not entitle me to receive any monetary or healthcare benefits from the Department of Campus Recreation or Texas State University.
 I understand that Texas State University will not provide me with any type of medical or liability insurance for my participation as a coach with a club.
 I understand that my acts and/or omissions in coaching a club may subject me to personal liability.
 I understand that I may be removed as a coach of a club if Campus Recreation determines that my removal is in the best interest of the club, its members, or the university.
 I have signed the Release and Indemnity Agreement for Sport Clubs Coaches, which is attached herein as Attachment 1.

Compensation:

In the event that a club elects to pay their coach, the specifics of the compensation, including the amount and payment frequencies, shall be mutually determined and documented in the Coach's Consent Form.

- o Payment of coaches must be paid through the club's agency or restricted account.
- Should the team not secure the requisite funds for the coach's payment, the obligation to compensate the coach shall be nullified.
- o Payments cannot be made more frequently than once every other month and Campus Recreation cannot guarantee a specific date of payment.
