Kama Davis – Attorney for Students

- A) The office started after Vietnam vets needed help once they came back to school. They give tools to self-advocated and learn what to do in the legal world. Introduced Mikala who is a student who had housing issues that included a broken water meter that over charged the bill. The leasing office said it was her water usage that caused this large bill. If it wasn't for AFS she wouldn't have made it through the legal issue. Areas of expertise include rental issues, ticketing, alcohol issues, immigration, name changes, employment, credit and debt issues, accidents and insurance, and powers of attorney. Vice President Pro Temp Myers talked about this (she went and got a living power of attorney and got a will). Introduced Isabella to talk about a medical issue (she had a medical emergency right before finals and lost her health insurance the week before). In housing specifically, there are two types of leases. Joint lease: everyone is equally liable for the entirety of the lease and the roommates you sign with are guaranteed to be your roommates. Individual lease: you rent the room, but still could be liable and assigned a random roommate. Prorated and lower rent is a regular benefit of a joint lease. Mikaela came back up to talk about how her boyfriend was promised to be assigned to the apartment with his same friends from the previous year but ended up getting moved into a random assignment.
