#### **Registrations Dates**

- Justice of the Peace Registration Date
  - o Tuesday, October 8, 2024
- Court Personnel Early Registration Opens
  - o Tuesday, October 22, 2024
- Court Personnel Early Registration Closes
  - Thursday, October 24, 2024
- Court Personnel Open Registration
  - o Monday, October 28, 2024

#### **How to Register**

- Please set up your TJCTC account before registration begins in October.
- We have created a webpage (https://www.tjctc.org/access-your-student-account/how-to-guides.html) that has step-by-step guides on how to create your TJCTC account and how to register. We encourage you to check it out before registration opens.

#### **Conference Registration Limits**

• Every year you may register for only one TJCTC conference. If you are found to have registered for two or more conferences, you will be removed from all of them and will need to re-register for only one. We cannot guarantee that this will not place you on a waitlist. There are no limits on JPCA conference, workshop, or webinar registrations.

#### **Early Registration For Court Personnel**

Were you not able to register last year? TJCTC offers early registration to court personnel who were
not able to attend a conference the year before. Early registration will begin on Tuesday, October
22, and end on Thursday, October 24. Open registration for all court personnel will open on Monday,
October 28. An email will be sent out to court personnel who are eligible for early registration.

#### Waitlist

• Every conference has a limited number of attendees that can register. If a conference is full, you can register to be put on the waitlist. The waitlist is organized by when you register. If spots in a conference become available, they will be filled from the waitlist in the order of registration. If a spot opens to an attendee on the waitlist, an automatically generated email will be sent to let them know. You have 4 days (96 hours) to log into your TJCTC account to confirm your registration. After that time, the spot will be automatically offered to the next person on the waitlist, and you will be moved to the end of the waitlist. Registering for the waitlist does not guarantee entry into a program.

#### **General Information**

#### **Attendee Cancellation**

- Cancellation must be submitted through your TJCTC account and received two (2) weeks prior to
  the conference start date in order to receive a full refund. If you must cancel your registration within
  two (2) weeks of the conference, email your cancellation to our Office Coordinator, Francisco
  Paredes at <a href="mailto:fip12@txstate.edu">fip12@txstate.edu</a>. No refunds or credits will be given for no-shows, late arrivals, or early
  departures.
- If you no-show for a conference without an approved reason, you will not be refunded, or if payment has not been received, you will still be expected to pay.
- If a clerk no-shows to a conference they will be suspended and unable to register for a conference or the rest of the current year and the following year.

#### **Clerk Substitutions**

• Our new registration system will not allow substitutions. When a person cancels from a conference, the next person on the waitlist will be offered that slot.

#### **Registration and Overhead Assessment Fee**

- Enrollment is subject to receipt of a registration fee from each attendee. The registration fee provides for program costs and meals. Pursuant to grant conditions, the registration fee is mandatory and given to the grant to be spent as restricted funds. If you or your county cannot pay this fee, please contact Thea Whalen at td24@txstate.edu to inquire about a waiver.
- The Texas State overhead assessment fee is a voluntary fee deposited into TJCTC's private fund account and is used for unrestricted activity expenses that the grant cannot cover, such as salaries, benefits, and excess food and lodging costs.
- The fees are currently split at 40% registration fee and 60% overhead assessment fee. The registration fee should be paid in full prior to the start of the event. TJCTC accepts credit cards, eChecks, personal checks, county checks, money orders, or purchase orders.

#### **Transferring Fees**

• Fees can no longer be transferred from one conference to another. If you wish to switch to a different conference, you will need to cancel your current registration and register for the new conference. Your original payment will be refunded, and you will need to resubmit payment.

#### **Hotel Lodging Fee**

• There is a \$60 per night hotel lodging fee, regardless of location. This is a voluntary fee to cover the difference between the grant-allowed GSA rate and the cost charged by the property. This cost allows education conferences to continue to be held in preferred locations throughout the state.

#### **Hotel Reservations**

- Lodging is available as an add-on to your registration. If you would like a room for yourself or are bringing your spouse/family, you will choose "Single Occupancy" and will be charged a \$60 lodging fee for every night of the conference. For attendees who opt for a double occupancy room with another attendee, TJCTC will waive the lodging fee, and the attendee will only be responsible for the registration and overhead assessment fees. Make sure to enter the double occupancy discount code at check out.
- If you select single or double occupancy, TJCTC will manage your reservations at the hotel for each night of an event. There is no need to contact the hotel regarding reservations.
- If you would like extra nights, please contact your Program Administrator.

#### **Judicial Education Information**

The Court of Criminal Appeals released changes to the Rules of Judicial Education starting in the FY22 academic year. Judges can receive up to 10 hours of credit from online learning, including civil hours. TJCTC will be offering two types of programs in FY2025:

- 10-Hour Conference
  - This program will consist of 10 hours of live education, covering a variety of civil and criminal topics.
- 20-Hour Conferences
  - These programs will cover all 20 hours needed for your education requirements, including enough civil courses to cover the 10 hours required.

Judges are required to get 10 hours of in-person education this year. If you have a health issue that prevents you from doing this, please contact Jessica Foreman at jessforeman@txstate.edu.

#### **Judicial Education Requirements**

- There are new and additional judicial education requirements this year.
- All experienced judges need a total of 20-hours, including 10 civil hours, 10 hours in-person, a magistration refresher course (if not taken in FY24), and a juvenile diversion course.

#### **Registration Categories**

#### **New Court Personnel**

New clerk conferences are for clerks who have less than one (1) year of experience in a justice court. You may attend a new clerk conference if you have 1-2 years of experience in a justice court. If you have more than 2 years of experience in a justice court you must register for the experienced clerk conferences.

These conferences will cover a variety of topics including civil, criminal, and professional development. Contact our Court Personnel Program Administrator, Darby Swoboda, at d\_s520@txstate.edu or 512-347-9927, for more information.

#### **Experienced Court Personnel**

Experienced clerk registration is for clerks who have completed a TJCTC conference and/or have at least one (1) year of experience working in the justice courts. Experienced clerks cannot register for the New Clerk conferences.

#### **Clerk Certification Program**

TJCTC offers two types of certification exams: The Level 1 Clerk Certification Exam - in Criminal or Civil - and the Level 2 Master Clerk Certification Exam. It is the recommendation of the Training Center that clerks complete a conference prior to taking an exam. Clerks must pass either the Civil or Criminal Level 1 exam prior to signing up for the Master Clerk Certification Exam. Study guide modules are available on our website.

The cost of an exam is \$25 per person, per test, and can be paid by credit card or ACH.

We are excited to offer online testing this year. We will still be administering exams in person at our office. Please check our website for the most up-to-date information on testing availability.
