Mistake 1 – Not Moving Cases Along

New Case Clearance Reporting

- Not in justice court yet, but may be coming!
- HB 841/1182 from 2023 Legislative Session requires case-level information, rather than aggregate data. Why does that matter?

Mistake 2 – Not Keeping Up With the Law

PSR and required training in magistration – authority to set bail



What if the magistrate wasn't legally authorized to set bail, and the defendant either made bail or failed to make bail?

Mistake 3 – Ignoring Appearances

- Liv is in line waiting to file a small claims case. There is a person in front of her who is taking a long time. Dominik is sitting at another window and she asks him if he can help her and he tells her he isn't able to take small claim filings. He goes back to scrolling his phone while she waits.
- How does this reflect on the court and the judiciary?
- What are some ways this could be addressed?

Mistake 3b – Ignoring Appearances

- Brent arrives at the court ready for his trial for speeding. He is in the lobby and the officer who wrote his ticket arrives. The clerk says "Steve!" and gives him a hug. After Brent is convicted, he hears the judge discussing with the officer plans to play in the upcoming golf scramble.
- How does this reflect on the court and the judiciary?
- What are some ways this could be addressed?

Mistake 4 – No Set Policies/Procedures

- How do you treat and evaluate requests for continuances? What about requests for deferred disposition?

Mistake 5 - Attention to Detail

 You fail to tell a tenant to pay monthly rent into the courts registry when they appeal an eviction case. Five days later, the landlord comes in wanting their writ.

Mistake 5b – Attention to Detail

Court had a civil hearing and the defendant appeared and plaintiff didn't. Case was continued to a dismissal docket.

Plaintiff hired an attorney who appeared at dismissal docket so case reset for trial.

Meanwhile, the defendant submitted a new address, which the clerk inadvertently entered for plaintiff, so defendant didn't get new court setting.

Default entered for plaintiff. Plaintiff now has a writ of garnishment and defendant has appeared livid due to their bank account being frozen for a case they thought was over with.

Mistake 6 – "Hey, an attorney said..."

- You sign an agreed judgment that includes the following terms:
 - Diane Defendant must pay \$500 per month on the 1st of each month until the judgment is paid in full. If she does, Paula Plaintiff may not obtain a writ of execution.
- Scenario 1 Paula comes to your office and says Diane missed a payment and so should be held in contempt for disobeying the judgment.
- Scenario 2 Paula comes to your office and requests a writ of execution. Should you verify if Diane is current on payments before issuing the writ?

Mistake 7 – Access to Justice Issues

- What if a party needs an interpreter and can't afford to pay for one up front?
- Gina walks in to ask the court how much it costs to file a small claims case. The clerk says "\$154." Gina frowns, says "well, guess I just can't afford justice here" and leaves. What could have been better?

Mistake 7b – Access to Justice Issues

Mistake 9 – Public Courts Issues

Mistake 10 – Good Intentions

- Defendant calls wanting to contest his citation. Clerk opens the case and sees that the fine was paid online and it is closed.
- Defendant states he did not pay it and wants to know how it got paid. Clerk states she can get that information, but will need to call him back.
- Defendant calls back stating that his mother took it upon herself to pay the citation for him after she saw it sitting on the counter, but still wants to contest it. The clerk finds that the credit card that paid it is in his mother's name.
