

NetID Activation, Class Registration, and Tuition Payment

Dear New International Student,

As the upcoming semester draws nearer, it is a great opportunity for us to review topics of interest to you as an international student: **Activating your NetID, Registering for Classes, and Paying Tuition**. These are interconnected and we encourage you to read through this email to gain a better understanding of these subjects; they are *essential* to your success as a student!



Activating your NetID

To use most of the online services here at Texas State University (TXST), you need to activate your NetID. Your NetID is like a username, in that it is uniquely identified with you. Among other features, it gives you access to your TXST email address. Registering for Classes

Only after you have activated your NetID can you register for classes. Information about class registration will be provided in detail to you depending on what level of study you are. The following table illustrates these sources of information by educational level:

link: <u>https://www.registrar.txst.edu/registration.html</u>. We know you are excited to plan your class schedule and embark on your academic pursuits here at TXST! However, you as an international student have a few extra considerations to keep in mind. The two main things

to remember are:

F-1 students are required to enroll Full-Time.

International students who are admitted to the United States in F-1 status are required by the Department of Homeland Security (DHS) to maintain the terms and conditions of their nonimmigrant status. Failure to do so can result in deportation. One of the requirements for maintaining F-1 status is to pursue a "full course of study" every semester, not including the summer break. A "full course of study" is considered full-time study, which at TXST is defined as **9 credit hours for graduate students** and **12 credit hours for undergraduates**.

Only one (1) distance learning class/online course per semester may be counted toward the full-time requirement.

- Classes considered "Distance Learning" are taken online or through correspondence and do not require the student's physical attendance for classes, examination, or other purposes integral to completion of the class.
- If you are not sure if a course is distance learning, check the syllabus, ask an academic advisor or International Student and Scholar Services (ISSS).
- A hybrid course that requires both online learning and face-to-face classroom meetings, for all students enrolled, counts as a face-to-face course.

Use the following table to see how many hours are required to maintain full-time enrollment (9 hours for graduates, and 12 hours for undergraduates) when taking an online course.

	Online	Face-to-Face
Graduate	3 hours	6 hours
Undergraduate	3 hours	9 hours



Paying your tuition

Once you have registered for classes, you will be able to make your tuition payment. For Exchange Students

Students will be billed through **Texas State Student Business Services (SBS).** The student bill will include:

- The international operations fee (\$180) and
- housing and meals (for students living on-campus)

*Please note that the student account will also show tuition and fees associated with registration at Texas State. These charges will be covered by

the Study Abroad Exchange Program according to the agreement between Texas State and the sending institution.
