# **Cruelly Treated Animals**

### Definition of "Cruelly Treated" - HSC Sec. 821.021(1)

#### "Cruelly treated" includes:

- Tortured;
- Seriously overworked;
- Unreasonably abandoned;
- Unreasonably deprived of necessary food, care, or shelter;
- · Cruelly confined;
- · Caused to fight with another animal; or
- Subjected to conduct prohibited by Penal Code Sec. 21.09 (Bestiality)

### Overview

- Animal control/peace officer applies for animal seizure warrant.
- If PC exists that animal was cruelly treated, judge issues warrant.
- Hearing:
  - If court finds no cruelty court orders animal returned to owner.
  - If court finds cruelty court orders owner to pay all court costs and one of the following:
    - · public sale of animal,
    - surrender of animal to a shelter, or
    - humane destruction of animal (if in best interests of the animal or for public health and safety).

# **Cruelly Treated Animals Scenario 2**

Multiple abandoned dogs left chained up with no access to food or water.

- 1. Does this meet the definition of cruelty?

### **Cruelly Treated Animals Scenario 3**

Multiple dogs to a crate in a van. It was hot out, but the doors were open and they had food/water.

- Does this meet the definition of cruelty?
- 2. Is there any additional info you would want?

### Cruelly Treated Animals Scenario 4

Your court is hearing a case where the allegation of cruelty is that two children mistreated their family dog. There is a video of a 15-year-old and a 7-year-old using a dog's leash to swing it around in the air in a circle and then letting go so that the dog flies through the air before hitting the ground. The dog is yelping and crying.

- 1. Does this meet the definition of cruel treatment?
- 2. Does the fact that the actions were done by minors impact the court's options?



# **Dangerous Dogs**

- Case Type 1: Serious Bodily Injury/Death
- Case Type 2/3: "Dangerous Dog" Determinations
- Case Type 4: Orders When "Dangerous Dog" Owner Fails to Comply with Statutory Requirements



### Who is Animal Control?

- 1. According to Health and Safety Code Ch. 822, who is the "animal control authority" when a dog must be seized and there is no animal control office with authority over the area?
- 2. What other resources/entities might be helpful in areas without an animal control office?

#### Case Type 1: Serious Bodily Injury/Death

A complaint is filed with the court that a dog has allegedly caused death or serious bodily injury to a person. If PC, Judge issues warrant for seizure of dog.



At hearing, judge determines whether the dog caused death or serious bodily injury and decides the disposition of the dog (destroyed or returned to owner).



If caused death = MUST order dog destroyed.

If caused serious bodily injury = MAY order dog destroyed UNLESS an exception applies, and then MAY NOT.

# Definition of Serious Bodily Injury:

an injury characterized by severe bite wounds or severe ripping and tearing of muscle that would cause a reasonably prudent person to seek treatment from a medical professional and would require hospitalization without regard to whether the person actually sought medical treatment.

# Dogs Scenario 1

An adult trespassed in a secured back yard and was breaking into the shed in the yard. The family dog attacked and killed the person.

• What are the court's options?

A man was providing lawn services when his client's dog escaped from its pen and attacked. The man lost his eye.

• What are the court's options? How would you rule?

# Dogs Scenario 3

The injury in this photo was caused in a dog attack.

 Would you determine that this is serious bodily injury or not?



A chihuahua attacked a person. It left scratch marks that did not bleed, but were red. It also bit the person, and did not break the skin, but left bruises.

 Would you determine that this is serious bodily injury or not?

# Dogs Scenario 5

The injuries in these photos were caused in a dog attack.

 Would you determine that this is serious bodily injury or not?





A 10-year-old was trespassing on private property where a dog was kept on the property using an invisible fence. The dog attacked, causing the injury in the photo.

What are the court's options?

#### Case Types 2 & 3: "Dangerous Dog" Determinations

A person wants to report a potentially dangerous dog.



Report is made to animal control authority.

Owner may APPEAL animal control determination to Justice Court.



If county has more than 2.8 million people or has elected to be governed by HSC 822.0422 –

Report is made directly to Justice Court under HSC 822.0422. Court notifies owner to deliver dog to animal control/issues seizure warrant if they don't.



At hearing, judge determines if the dog is a "dangerous dog." (If yes, statutory req.'s for dangerous dog owners are triggered)

### Definition of "Dangerous Dog" and Scenarios

Makes an unprovoked attack on a person that causes bodily injury
and occurs in a place other than an enclosure in which the dog was
being kept and that was reasonably certain to prevent the dog from
leaving the enclosure on its own;

#### or

• Commits unprovoked acts in a place other than an enclosure in which the dog was being kept and that was reasonably certain to prevent the dog from leaving the enclosure on its own and those acts cause a person to reasonably believe that the dog will attack and cause bodily injury to that person.

HSC Sec. 822.041(2)

#### Case Type 4: Failure to Comply w/ Statutory Reqs


An owner of a "dangerous dog" has allegedly failed to comply with the statutory requirements for a dangerous dog owner.



Any person may submit an application to the court alleging this.



Court may already be monitoring if heard case under Hearing Type 3 (report made directly to justice court under HSC 822.0422) and ordered dog to remain impounded until owner complied with requirements.



At hearing, judge determines whether owner failed to comply with statute, and if so, issues seizure warrant if dog is not already impounded and ultimately orders destruction of the dog if noncompliance continues after a certain amount of time.

- 1. What are the three ways that a dog owner can "learn" that they are a "dangerous dog" owner, thus triggering the statutory requirements for dangerous dog owners under HSC 822.042(a)?

### Dogs Scenario 9

An application is filed alleging that a dangerous dog owner has failed to comply with the statutory requirements. You follow all of the required procedures and at the hearing, you determine that the owner has failed to comply and order animal control to seize the dog. It has now been 12 days since the dog was seized and the owner still has not complied.

- 1. Is appeal an option for the different types of dog hearings?
- 2. What is the deadline?
- 3. What type of order is automatically stayed if issued by the court? For how long? Why?
