POLICY STATEMENT

The Department of Counseling, Leadership, Adult Education, and School Psychology (CLAS) is committed to hiring faculty who are qualified in their respective disciplines to meet the responsibilities and performance expectations associated with their job titles.

01. SCOPE

01.01	To ensure the quality and integrity of its academic programs, the CLAS Department appoints faculty members with the credentials and qualifications to effectively carry out their responsibilities.
01.02	To delineate faculty responsibilities and duties and performance expectations, including those for active participation in shared governance.
01.03	To identify titles for tenure-line and non-tenure-line faculty.

02. FACULTY QUALIFICATIONS

02.01	The CLAS Department hires qualified faculty as instructors of record to meet the teaching component of its mission. Instructors of record have overall responsibility for the development and implementation of the syllabus, as well as the right to evaluate student performance and assign grades.		
02.02	When making decisions to appoint faculty members as instructors of record, the CLAS Department gives primary consideration to the highest academic credential or degree earned in the discipline and follows the Faculty Credentials Guidelines of the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) and AA/PPS No. 04.01.20.

04. FACULTY TITLES

04.01	Tenure-line faculty are faculty who are eligible for consideration for tenure following a stipulated probationary period, or who have earned tenure. Titles for tenure-track and tenured faculty are identified in AA/PPS No. 04.01.20.
04.02	Non-tenure-line faculty (NLF) are faculty who are not eligible for tenure. Emeritus faculty are included in this group because tenure is surrendered at the time of retirement. Select NLF titles are eligible for promotion or are the result of promotion, including assistant professors, associate professors, and professors in research, clinical, instructional, or faculty of practice titles. Titles for NLF are identified and defined in AA/PPS No. 04.01.20.
04.03	Per-course faculty are paid a flat rate for teaching a class. This appointment is limited to a maximum of two 3–4-hour classes per semester. The only exception is the addition of one University Seminar (US 1100) class section to those two classes per semester. Titles for per course faculty are identified in AA/PPS No. 04.01.20.
