- III. **Approval of Minutes**
- IV. **Orders of the Day**
 - a. Appropriations for the Gradsgiving Event were deliberated and approved, resulting in an allocation of \$600 for catering and food expenses, and an additional \$200 for supplementary materials, as part of a negotiated compromise.
 - b. The second reading of the Graduate Electronic Submission Accessibility (GESA) Act, recommending the adoption of LaTeX as an acceptable submission format for Vireo, was presented before the House and, having received no objections, was passed by unanimous consent of the representatives. The Act shall now be forwarded to the Student Body President for ratification.
- V. **Guest Speakers**
 - a. Dr. Duane Bruce, Student Involvement
 - i. Budget
 - 1. Student Body President and Vice President receive paid positions, the House asked about the House Leader also being compensated. Dr. Bruce suggested that this could be brought forward to Graduate College.
 - 2. Resolutions proposing an increase to the House budget should be accompanied by a recommendation identifying the prospective sources of the additional funds.
 - ii. Graduate Student Organizations
 - 1. Discussion revealed that there is only \$20,000 annually in the funding pool for all RSO.
 - 2. Graduate students receive the majority of STAR grant funding, which only has an annual pool of \$25,000.
 - 3. Dr. Bruce suggested that a Representative of the House could sit on the committee that oversees approving funding requests for student organizations.
 - iii. Invite House Leader to Executive Retreat

1. Funding and budgetary decisions for Student Government, to include the House, are made by the Student Body President during the Executive Retreat every summer before the fall semester.
 2. The Representatives resolved to amend the Code of Laws to require that invitations to attend proceedings must be sent to the House Leader.
