1 **A Simple Resolution-**

2 To be known as "A Simple Resolution Confirming Supreme Court  
3 Justices" which submits for the confirmation of the newly  
4 recommended Student Government Court Justices.

5 **WHEREAS:** The Student Body Chief Justice, Muhammad Hanzala,  
6 proposed Elliot Downey & Diego Hernandez for nomination to  
7 continue serving in the role of Justice of the Supreme Court for  
8 the rest of the 61<sup>st</sup> legislative session of the Student  
9 Government of Texas State as required by the Student Government  
10 Code of Laws under Rules of Procedure in Article IV, Section 3,  
11 part A (pg.21); and,

12 **WHEREAS:** The Student Body Chief Justice, Muhammad Hanzala,  
13 proposed Sadie Smith, Angel Ramon, & Abigail Pickle for  
14 nomination to serve in the role of Justice of the Supreme Court  
15 for the rest of the 61<sup>st</sup> legislative session of the Student  
16 Government of Texas State as required by the Student Government  
17 Code of Laws under Rules of Procedure in Article IV, Section 3,  
18 part A (pg.21); and,

19 **WHEREAS:** The Supreme Court within the Student Government of  
20 Texas State University requires Four (4) Supreme Court Justices  
21 and One (1) Supreme Court Chief Justice that upon appointment  
22 serve one (1) term of two (2) years in length as required by the

23 Student Government Constitution Article VI, Section 5 (pg.14);  
24 and,

25 **WHEREAS:** The Court internally decides out of the five (5)  
26 appointed Justices, who will be promoted to the role of Chief  
27 Justice as required by the Student Government Code of Laws under  
28 Term Limits in Article III, Section 1 (pg.36); and,

29 **WHEREAS:** The Student Body Senate confirms that all candidates  
30 referenced herein as required by the Student Government  
31 Constitution Article VI, Section 4 (pg.14); therefore,

32 **BE IT RESOLVED:** The Student Body Senate appoints Elliot Downey,  
33 Diego Hernandez, Sadie Smith, Angel Ramon, & Abigail Pickle to the  
34 role of Justice of the Supreme Court for the rest of the 61<sup>st</sup>  
35 legislative session and the 62<sup>nd</sup> legislative session in its  
36 entirety effective December 13<sup>th</sup>, 2025; and

37 **BE IT FURTHER RESOLVED:** This legislation be forwarded to the  
38 Student Body President for further action.
