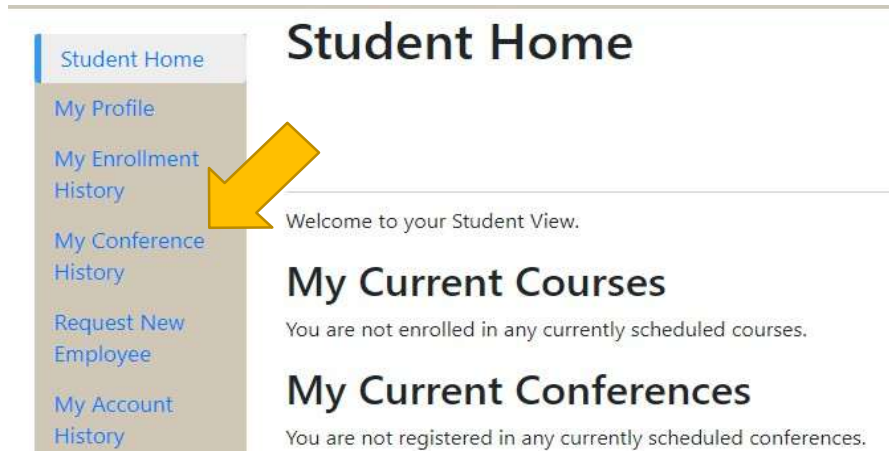


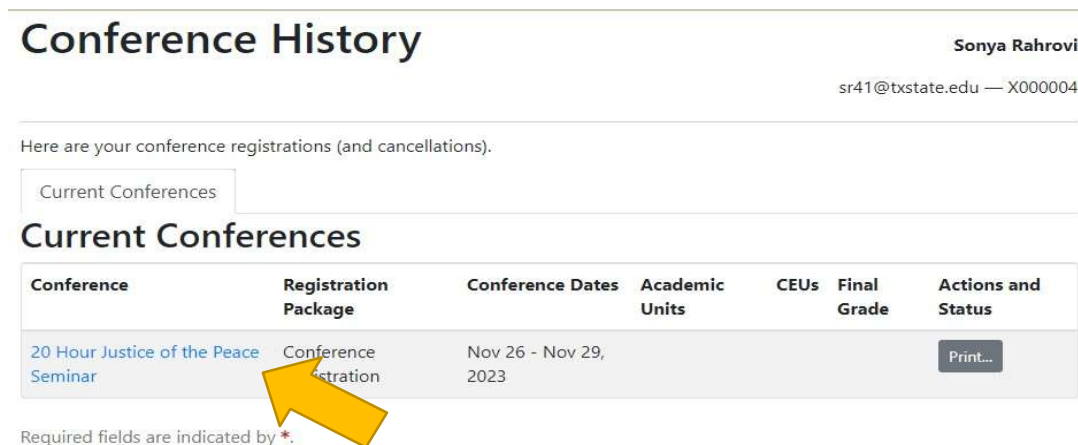
How to Choose your Conference Sessions:
